AN ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE OF SCHOOL ROAD, NEAR BULACAN SPORTS COMPLEX, BARANGAY BAGONG BAYAN, CITY OF MALOLOS, BULACAN, FOR THE CONSTRUCTION OF NORTH-SOUTH COMMUTER RAILWAY (NSCR) PROJECT (MALOLOS-TUTUBAN) PACKAGE CP02.

**WHEREAS**, Rule VIII, Article 43 of Rules and Regulations Implementing the Local Government Code of 1991, states that, *Closure and Opening of Roads or Parks, "Authority to Closure or Open - A local Government Unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling within its jurisdiction";*

**WHEREAS**, Rule VIII, Article 45 (3) of Administrative Order No. 270 or the Rules and Regulations Implementing the Local Government Code of 1991, states that, *"When public works projects or activities are being undertaken for a period as may be determined necessary for the safety, security, health, or welfare of the public or when such closure is necessary to facilitate completion of the projects or activities";*

**WHEREAS**, Sumitomo Mitsui Construction Co., Ltd. the Contractor of North-South Commuter Railway (NSCR) Project (Malolos-Tutuban) Package CP02 will be starting the aerial works (segment erection, installation of concrete barriers and parapet walls) inside PNR Right of Way Alignment that coincides with portions of the roads in the City of Malolos, Bulacan;

**WHEREAS**, the Contractor will temporarily close School Road, near Bulacan Sports Complex, Barangay Bagong Bayan, City of Malolos, Bulacan for safety and security of the public during the above-mentioned activities;

WHEREAS, there is thus a need to temporary close the affected roads from traffic within a required period of time, which act is within the powers of this Council under Section 458 (5) and (vi) and sanction by Section 21 (c), both of the Local Government Code of 1991;

NOW THEREFORE, on the motion of HON. DENNIS D. SAN DIEGO, and duly seconded by the Members present,

BE IT enacted by the Sangguniang Panlungsod of City of Malolos in a Session assembled, that:

SECTION 1. - COVERAGE - In connection with the above-mentioned purpose, the School Road, near Bulacan Sports Complex, Barangay Bagong Bayan, City of Malolos, Bulacan be temporarily closed to all vehicular traffic.

SECTION 2. - DURATION AND TIME - The temporary closure shall take effect for eighteen (18) days, from April 06 to April 23, 2022, pursuant to the letter request of Sumitomo Mitsui Construction Co., Ltd. the Contractor of North-South Commuter Railway (NSCR) Project (Malolos-Tutuban) Package CP02.

SECTION 3. - TERMS AND CONDITIONS - The following terms and conditions shall be implemented:

- a. That a substitute route with corresponding routing plan shall be provided;
- b. That the alternative route shall be properly maintained for public safety until such duration that the subject road will be opened back to public;
- c. That the provisions of international road signs be it informative and regulatory shall be strictly followed including installation thereto;
- d. That the appropriate traffic and public information signages and manpower in coordination with the Sangguniang Barangay concerned, City Traffic Management and Safety Office including the Philippine National Police, Force Multipliers and other appropriate agencies of the government are expected to be installed;
- e. That the residents of the area covered by the closure of road are expected to be well informed;
- f. That the temporary terminals for the affected TODA and pedestrian trail with proper lighting will be available during the road closure;
- g. That in cases of emergency the contractor shall provide specific route to allow the free flow of traffic to the responder or for an ambulance/rescue vehicle in responding said incident;
- h. That immediately after the closure, it is expected that the road will be restored and all obstructions will be removed so that motorists can use the road again; and
- i. That all relevant laws and department orders appertaining to the temporary closure of roads and security protocol specifically relative to Proclamation No. 216 including its guidelines shall be strictly implemented.

SECTION 4. - Pursuant to the above terms and conditions, the temporary closure of the school road is hereby approved for public safety and convenience.

SECTION 5. - ADMINISTRATIVE PROVISION - The Office of the City Engineering, Office of the City Planning and Development and the Office of the City Traffic Management and Safety shall monitor the proper implementation of this Ordinance.

SECTION 6. - PENAL PROVISIONS - The pertinent provisions of the Traffic Code of the city shall be invoked for any offense or traffic infraction committed during the implementation of this Ordinance.

SECTION 7. - SEPARABILITY CLAUSE - If, for any reason, any section or provision of this Ordinance is disallowed or declared invalid by proper authorities, other sections, or provisions hereof that are not affected thereby shall remain in full force and effect.

SECTION 8. - EFFECTIVITY - This Ordinance shall take effect upon its approval.
