AN ORDINANCE AMENDING SECTION 2 OF CITY ORDINANCE NO. 09-2022, ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE OF PASEO DEL CONGRESO-NORTHBOUND SPAN, CITY OF MALOLOS, BULACAN FOR THE CONSTRUCTION OF NORTH-SOUTH COMMUTER RAILWAYS (NSCR) PROJECT (MALOLOS-TUTUBAN) PACKAGE CP02'.

WHEREAS, on May 23, 2022, the Honorable Sangguniang Panlungsod passed City Ordinance No. 09-2022 entitled "an Ordinance authorizing the temporary closure of Paseo del Congreso-Northbound Span, City of Malolos, Bulacan for the construction of North-South Commuter Railways (NSCR) Project (Malolos-Tutuban) Package CP02;'

WHEREAS, on July 15, 2022, Sumitomo Mitsui Construction Co. Ltd., contractor of the said project, notified this Honorable body through letter on the minor movement of dates of the temporary closure of the said against the requested date that was used in the issued City Ordinance;

NOW THEREFORE, on the motion of HON. DENNIS D. SAN DIEGO, and duly seconded by the Members present,

BE IT enacted by the Sangguniang Panlungsod of City of Malolos in a Session assembled, that:

SECTION 1. - Section 2 of City Ordinance No. 09-2022 shall be amended and read as follows:





'The temporary closure shall take effect for seventeen (17) days, from July 23 to August 8, 2022, pursuant to the letter request of Sumitomo Mitsui Construction Co., Ltd. the Contractor of North-South Commuter Railway (NSCR) Project (Malolos-Tutuban) Package CP02.

SECTION 2. - EFFECTIVITY - This Ordinance shall take effect upon its approval.
