A CITY RESOLUTION APPROVING AND ADOPTING THE ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY GOVERNMENT OF MALOLOS FOR FISCAL YEAR 2022 IN THE AMOUNT OF THREE BILLION, FOUR HUNDRED TEN MILLION, FOUR HUNDRED THIRTY THOUSAND, SEVEN HUNDRED EIGHTY FIVE PESOS AND NINETY ONE CENTAVOS (PHP3,410,430,785.91) AND THE 20% DEVELOPMENT FUND IN THE AMOUNT OF TWO HUNDRED TWENTY THREE MILLION SIX HUNDRED FOURTEEN THOUSAND ONE HUNDRED SIXTY FOUR PESOS (PHP223,614,164.00).

WHEREAS, Article 182 of Rule XXIII of Implementing Rules and Regulations of Republic Act No. 7160 mandates every Local Government Units (LGUs) shall pass and adopt a comprehensive multi-sectoral development plan to be initiated by the Local Development Council (LDC) and approved by the concerned Sanggunian;

WHEREAS, the Annual Investment Program (AIP) is a legal instrument by which a Local Government Unit (LGU) annually manages its financial condition in support of its Local Development Plan (LDP) and Local Development Investment Program (LDIP);

WHEREAS, the City of Malolos Development Council (CMDC) approved the Annual Investment Program (AIP) and the allocation of the 20% Development Fund for the Fiscal Year (FY) 2022 of the City Government of Malolos thru the CMDC Resolution No. 09-2021 dated September 17, 2021;

WHEREAS, the Department of Interior and Local Government - National Economic Development - Department of Budget and Management - Department of Finance (DILG-NEDA-DBM-DOF) Joint Memorandum Circular (JMC) No. 1, Series of 2016 defines the Annual Investment Program (AIP) as the annual slice of the Local Development Investment Plan (LDIP), which constitutes the total resource requirements for all the programs, projects and activities (PPAs) of the annual capital expenditure and regular operating requirements of the local government unit;

WHEREAS, the Department of Interior and Local Government (DILG) - Department of Budget and Management (DBM) Joint Memorandum Circular No. 2017-01 dated February 22, 2017 provides updated guidelines on the appropriation and utilization of the twenty percent (20%) of the Annual Internal Revenue Allotment (IRA) for the development programs;

WHEREAS, the Department of Interior and Local Government (DILG) - Department of Budget and Management (DBM) Joint Memorandum Circular No. 01 dated 27 March, 2020, provides additional guidelines on the utilization of the twenty percent (20%) of the IRA for the development programs in view of the Corona Virus Disease 2019 (COVID-19) situation;

WHEREAS, the Annual Investment Program (AIP) embodies the entire service requirements and expenditures of the city for the ensuing year;

WHEREAS, the approval and adoption of the Annual Investment Program (AIP) is a pre-requisite and a condition necessary before the enactment of the Annual Appropriation Ordinance;

WHEREAS, after a careful review of the Annual Investment Program (AIP) for Fiscal Year 2022 of the City Government of Malolos, is in accordance with the city development thrusts and with the specific objectives and policies of the Local Government Unit;

NOW THEREFORE, on the motion of **Hon. Nino Carlo C. Bautista**, duly seconded by the Members present,


RESOLVED, as it is hereby resolved, to approve and adopt the Annual Investment Program (AIP) of the City Government of Malolos for Fiscal Year 2022 in the amount of THREE BILLION, FOUR HUNDRED TEN MILLION, FOUR HUNDRED THIRTY THOUSAND, SEVEN HUNDRED EIGHTY FIVE PESOS AND NINETY ONE CENTAVOS (PHP3,410,430,785.91) and the 20% Development Fund in the amount of TWO HUNDRED TWENTY THREE MILLION SIX HUNDRED FOURTEEN THOUSAND ONE HUNDRED SIXTY FOUR PESOS (PHP223,614,164.00).


