WHEREAS, Section 333 of Republic Act 7160 otherwise known as the Local Government Code of 1991, states that the Sangguniang Panlungsod as the Legislative Body of the City, shall have the power to review barangay budget ordinances in order to ensure compliance thereof with all the budgetary requirements and limitations provided for by law;

WHEREAS, the Sangguniang Kabataan of Barangay Niugan has submitted to the City Budget Officer an annual budget of Three Hundred Sixty Nine Thousand Two Hundred Eighty Three Pesos and Twenty Six Centavos (PhP369,283.26);

WHEREAS, after review the same has been found compliant with the requirements set forth under the Local Government Code of 1991, the SK Reform Act of 2015 and other existing laws and issuances;

NOW THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod in session assembled, to declare the Annual Budget of the Sangguniang Kabataan of Barangay Niugan for the Calendar Year 2022 in the amount of Three Hundred Sixty Nine Thousand Two Hundred Eighty Three Pesos and Twenty Six Centavos (Php369,283.26) operative in its entirety.






