

CITY RESOLUTION NO. 144-2022

A RESOLUTION RESPECTFULY RECOMMENDING THE GRANT OF APPROVAL OF THE MOTION TO RELEASE ON RECOGNIZANCE FILED BY ARTSON ESUGA Y ALEJANDRO OF BARANGAY COFRADIA, THIS CITY BEFORE THE REGIONAL TRIAL COURT, THIRD JUDICIAL REGION, BRANCH 84 FOR VIOLATION OF SECTION 12, ARTICLE II, REPUBLIC ACT NO. 9165, OTHERWISE KNOWN AS THE COMPREHENSIVE DANGEROUS DRUGS ACT OF 2002.

WHEREAS, August 16, 2022, this office has received a letter from Mr. Brix A. Esuga of Barangay Cofradia, City of Malolos, Bulacan and the brother of Artson Esuga y Alejandro, requesting for the approval of Sangguniang Panlungsod Resolution for the Motion to Release of Recognizance, and the copy of Non-Government Organization (NGO's) is attached in the said letter;

WHEREAS, Section 13, Article III of the 1987 Constitution provides that all persons, except those charged with offenses punishable by reclusion perpetua when evidence of guilt is strong, shall before conviction, be bailable by sufficient sureties, or be released on recognizance as may be provided by law;

WHEREAS, Republic Act No. 10389, otherwise known as the "Recognizance Act of 2012" was enacted to uphold the mandate of the Constitution by institutionalizing recognizance as a mode of granting the release of an indigent accused in a criminal case in custody of the law;

WHEREAS, the Sanggunian upon receipt of the said letter has acted upon the order of the Court and immediately required the representative of the accused to submit before the Sanggunian all the documents needed for the consideration of the Council and for its legislative action pursuant to Section 6, (d) of the said Republic Act No. 10389;


