WHEREAS, Section 13, Article III of the 1987 Constitution provides that all persons, except those charged with offenses punishable by reclusion perpetua when evidence of guilt is strong, shall before conviction, be bailable by sufficient sureties, or be released on recognizance as may be provided by law;

WHEREAS, The Sanggunian upon receipt of the said order has acted upon the order of the Court and immediately required the representative of the accused to submit before the Sanggunian all the documents needed for the consideration of the Council and for its legislative action pursuant to Section 6, (d) of the said Republic Act No. 10389;

WHEREAS, after thorough evaluation of the records submitted and upon coordination with NGO Presidents, the Council believes that the peace of the community will not be disturbed upon the temporary release of the accused, hence, **ENDORSES THE APPROVAL OF THE APPLICANT FOR RECOGNIZANCE:**

WHEREAS, the Sangguniang Panlungsod submits to the discretion of the court to choose from the list of Non-Government Organizations with their respective Presidents who may be appointed as custodian of MR. JOSELITO MARASIGAN Y PERONA:
