GATCHALIAN, TO SIGN AND ENTER INBEHALF OF THE CITY GOVERNMENT OF MALOLOS INTO A CONTRACT OF SERVICE (MEMORANDUM OF AGREEMENT) WITH THE PHILIPPINE LONG DISTANCE TELEPHONE COMPANY FOR ITS FIBER TO THE BUILDING PROGRAM TO THE NEW MALOLOS CITY HALL LOCATED AT BARANGAY BULIHAN, CITY OF MALOLOS.

**WHEREAS**, Section 16 of Republic Act. No. 7160 also known as the Local Government Code of 1991 mandates the implementation of projects and programs by the Local Government Units (LGUs) that will rebound to the general welfare of its constituents;

**WHEREAS**, Kautusang Panlungsod Blg. 23-2020 was enacted by the Honorable City Council authorizing the transfer of the seat of power of the City Government of Malolos from its present location to the New City Hall located at Barangay Bulihan, City of Malolos, Bulacan;

**WHEREAS**, the Honorable City Mayor through a letter (Certified Urgent) asked for an authorization to enter into a contract with the Philippine Long Distance Telephone Company for its Fiber to the Building (FTTB) program;

**WHEREAS**, the primary objective of the City Government of Malolos is to give effective and efficient delivery of services to its constituents with the use of technological advancement in its transactions;

**WHEREAS**, this Agreement shall remain in effect for a period of three (3) years beginning on the date of signing of the contract and if there is mutual interest in continuing, the parties may renew the contract according to its terms;

**WHEREAS**, Section 22 (c) of Republic Act No. 7160 also known as the Local Government Code of 1991 provides that before a Chief Executive may enter and sign into any contract in behalf of the Local Government Unit concerned, there is a need for a prior authorization from the Sangguniang Panlungsod;
