WHEREAS, Rule IX, Section 88 of Civil Service Commission (CSC) Memorandum Circular No. 24 S. 2017 dated August 24, 2017 "2017 Omnibus Rules on Appointment and other Human Resource Action" adopted and promulgated through CSC Resolution No. 1701009 dated June 16, 2017 requires for the creation of the Human Resource Merit Promotion and Selection Board (HRMPSB);

WHEREAS, there is an essential need to establish the HRMPSB to comprehensively respond to updated personnel recruitment, selection and promotion process in the city government;






