CITY ORDINANCE NO. 13-2020

AN ORDINANCE PROHIBITING THE SELLING AND DISTRIBUTION OF ALCOHOLIC BEVERAGES IN THE CITY OF MALOLOS WHILE THE CITY IS UNDER THE ENHANCED COMMUNITY QUARANTINE CAUSED BY COVID-19.

WHEREAS, Section 2 of Presidential Proclamation No. 922, declared a state of Public Health Emergency throughout the Philippines in which LGU's are hereby enjoined to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent, and appropriate response and measures in a timely manner to curtail and eliminate the Covid-19 threat;

WHEREAS, Article II, Section 4 of the City Ordinance No. 10-2020 declares a State of Calamity within the territorial jurisdiction, in view of the high incidence of Covid-19 in the Philippines and in the National Capital Region;

WHEREAS, under Section 16 of the Local Government Code provides that "The State shall protect and promote the health and safety of the people";

WHEREAS, Section 458 (ii) of the same Code provides that Sangguniang Panlungsod shall maintain peace and order and Section 458 (iv) of the same shall adopt measures to protect the people of the city from the harmful effects of calamities;

NOW, THEREFORE, BE IT ORDAINED, by the Sangguniang Panlungsod of Malolos, in session that:

SECTION 1. - LIQUOR BAN - Selling and Distribution of liquor or alcoholic beverages in the City of Malolos are hereby strictly prohibited while the City is under Enhanced Community Quarantine caused by Covid-19.

SECTION 2. - This Ordinance shall be imposed in the city until such time that the City Council declares the lifting of such.

SECTION 3. - PENALTY - Any person or entity violating any of the provisions of this ordinance shall be fined amounting to Five Thousand Pesos (Php5,000.00) and for the subsequent violation/s amounting to Five Thousand Pesos (Php5,000.00) and cancellation of business permit.




