AN ORDINANCE LIFTING AND REPEALING THE PROHIBITIONS STATED UNDER CITY ORDINANCE NO. 13-2020 ALSO KNOWN AS LIQUOR BAN IN THE CITY OF MALOLOS.

EXPLANATORY NOTES

WHEREAS, Section 2 of Presidential Proclamation No. 922, declared a state of Public Health Emergency throughout the Philippines in which LGU's are hereby enjoined to render full assistance and cooperation and mobilize the necessary resources to undertake critical, urgent and appropriate response and measures in a timely manner to curtail and eliminate the COVID-19 threat;

WHEREAS, Article II, Section 4 of the City Ordinance No. 10-2020 declares a State of Calamity within the territorial jurisdiction, in view of the high incidence of COVID-19 in the Philippines and in the National Capital Region;

WHEREAS, under Section 16 of the Local Government Code provides that the state shall protect and promote the health and safety of the people;

WHEREAS, the National Inter-agency Task Force (IATF) recommended the lifting of Enhanced Community Quarantine (ECQ) in the entire Region III including the Province of Bulacan and thru an Executive Order issued by His Excellency Rodrigo Roa-Duterte (President, Republic of the Philippines), the Province of Bulacan was placed under Modified Enhanced Community Quarantine or MECQ from May 16 60 May 31, 2020;

WHEREAS, Honorable City Mayor, Engr. Gilbert T. Gatchalian thru His Executive Order No. 29-2020 entitled PAGTATAKDA NG MGA PANUNTUNANG IPAPATUPAD SA LUNGSOD NG MALOLOS MULA IKA-16 MAYO HANGGANG IKA-31 NG MAYO KAUGNAY SA MODIFIED ENHANCED COMMUNITY QUARANTINE (MECQ) under Section XIII 'Ipinagbabawal ang pag-inom ng alak sa labas ng sariling bahay';

WHEREAS, the lifting of selling and distribution of Alcoholic Beverages in the City is not tantamount in any way to encourage the people to drink where in fact, the City Council still discourage its constituents from drinking;

NOW THEREFORE, BE IT ORDAINED, by the Sangguniang Panlungsod of the City of Malolos in session assembled, that:

SECTION 1. LIFTING OF LIQUOR BAN. The prohibition under City Ordinance No. 13-2020, selling and distribution of Alcoholic Beverages is hereby lifted and repealed.

SECTION 2. SEPARABILITY CLAUSE - If any provision or part of this Ordinance is declared invalid or unconstitutional, the other parts or provisions thereof shall remain valid and effective.

SECTION 3. EFFECTIVITY - This Ordinance shall take effect immediately upon approval.
