CITY ORDINANCE NO. 26-2022

AN ORDINANCE AUTHORIZING THE GRANTS OF RELIEF ON ALL SURCHARGES AND INTERESTS ON LOCAL TRANSFER TAXES ON ESTATES OF DECEDENT/S WHO DIED ON OR BEFORE 31 DECEMBER 2017 AND SHALL BE AVAILED BY THE LEGAL HEIR/S ADMINISTRATOR OR EXECUTOR UNTIL 14 JUNE 2023.

WHEREAS, on 28 March 2022, the Bureau of Local Government Finance (BLGF), Region III together a copy Department Circular (DC) No. 001.2022 dated 07 March 2022 issued by the Secretary of Finance, on the Supplemental Guidelines on the Grant of Relief on Surcharges and Interest on Local Tax on Transfer of Real Property Ownership in support of the Extension of the Estate Tax Amnesty Program;

WHEREAS, on 07 of April 2022, the Office of the City Mayor together with the 1st indorsement of the City Treasurer, forwarded the said to the Office of the Sangguniang Panlungsod;

NOW THEREFORE, on motion of Hon. Therese Cheryll B. Ople, duly seconded by all Members present,

BE IT ORDAINED, by the Members of the City Council of Malolos in session duly assembled, that:

SECTION 1. GRANT OF LOCAL TRANSFER TAX RELIEF.

- a. The grant of Local Transfer Tax relief shall impose only on all surcharges and interest on local transfer taxes on estates of decedent/s who died on or before 31 December 2017 and shall be availed by the legal heir/s, administrator or executor.
- b. The grant of Local Transfer Tax relief shall be applied to transfer on real property ownership by succession only, and in no case shall apply to other kinds of transfer.

c. The grant of relief on surcharges and interests on Local Tax on Transfer of Real Property Ownership shall be availed until 14 June 2023.

SECTION 2. - The City Treasurer together with the City Assessor shall be in charge for the implementation of the said program.

SECTION 3. - SEPARABILITY CLAUSE - If for any reason, any part, section or provision of this ordinance shall be held invalid or unconstitutional, other provisions or parts thereof not affected thereby shall remain in full force and effect.

SECTION 4. - EFFECTIVITY - This ordinance shall take effect immediately upon approval.




