A CITY ORDINANCE AMENDING CITY ORDINANCE NO. 18-2020 ALSO KNOWN AS "A CITY ORDINANCE APPROVING AND AUTHORIZING SUPPLEMENTAL BUDGET NO. 1 OF THE CITY OF MALOLOS IN THE AMOUNT OF ONE HUNDRED THIRTY-SIX MILLION EIGHT HUNDRED TWENTY-THREE PESOS AND FORTY-FIVE CENTAVOS (PHP136,823,443.45) TO BE USED AS AUGMENTATION IN ITS EFFORT IN COMBATING, CONTAINING AND FIGHTING COVID-19 PANDEMIC", TO INCLUDE/MANDATE THE OPENING OF A SPECIAL ACCOUNT IN THE GENERAL FUND FOR THE BAYANIHAN FUND," AND FOR OTHER PURPOSES.

EXPLANATORY NOTE

WHEREAS, on April 15, 2020, the Honorable Sangguniang Panlungsod passed City Ordinance No. 18-2020 entitled "a City Ordinance approving and authorizing Supplemental Budget No. 1 of the City of Malolos in the amount of One Hundred Thirty-Six Million Eight Hundred Twenty-Three Pesos and Forty-Five Centavos (Php136,823,443.45) to be used as augmentation in its effort in combating, containing and fighting COVID-19 Pandemic";

WHEREAS, the National Government through Bayanihan Grant to Cities and Municipalities transferred Php64,764,795.00 (equivalent to one (1) month Internal Revenue Allotment (IRA) to the City Government of Malolos to help the City in its fight against COVID-19 Pandemic;

WHEREAS, Local Budget Circular No. 125 dated April 07, 2020 mandates the opening of a Special Account in the General Fund for the said Fund:

WHEREAS, as of June 03, 2020, the unexpended portion of the said Bayanihan Grant is Php4,509,035.00.
