CITY ORDINANCE NO. 41-2020

AN ORDINANCE AMENDING SECTION 6 OF CITY ORDINANCE NO. 14-2017 ALSO KNOWN AS THE CITY YOUTH DEVELOPMENT ORDINANCE, PROVIDING FOR THE REGISTRATION AND VERIFICATION OF YOUTH AND YOUTH-SERVING ORGANIZATIONS IN THE CITY OF MALOLOS AND THE MANNER OF ELECTION OF CYLDC AND FOR OTHER PURPOSES.

EXPLANATORY NOTE

WHEREAS, the Sangguniang Panlungsod enacted City Ordinance No. 14-2017 also known as the City Youth Development Ordinance authored by Hon. Nino Carlo C. Bautista on May 11, 2017 to empower the Youth Sector, encourage the youth to participate in socio-civic activities and in the affairs of the government as well as the creation of the City Local Youth Development Council;

WHEREAS, on August 8, 2018, the Department of the Interior and Local Government (DILG) issued DILG Memorandum Circular No. 2018-124 to serve as the guiding principle for the establishment of the Local Youth Development Council (LYDC) in each Local Government Units as mandated under section 23, Chapter III of Republic Act No. 10742 or the Sangguniang Panlungsod Reform Act of 2015;

WHEREAS, Section 24 (b), Rule III of the Implementing Rules and Regulations (IRR) of RA 10742 states that "To give equal opportunity for the youth, from the time of the enactment of these rules up to the deadline for registration set by the Commission and DILG, non-organized youth groups may formally organize themselves and register in accordance with paragraphs d and e of this section";

WHEREAS, all concerned LGU Officials and DILG Officers are enjoined to perform their respective roles, duties and functions in the conduct of Registration of YOs and YSOs and Election of LYDC members;

NOW THEREFORE, BE IT ORDAINED, by the Sangguniang Panlungsod of the City of Malolos in session assembled, that:

SECTION 1. - This City Ordinance is hereby amending the provisions of Section 6 of City Ordinance No. 14-2017, and shall be read as:

"COMPOSITION OF THE CITY LOCAL YOUTH DEVELOPMENT COUNCIL (CYLDC) - The City Local Youth Development Council (CYLDC) shall be composed of at least ten (10) but not more than twenty-one (21) members such as:

and 19 representatives of the different registered Youth Organizations (YO's) or Youth-Serving Organizations (YSO's) in the Provincial and City Level."

SECTION 2. - GENERAL QUALIFICATIONS OF THE MEMBERS OF THE LYDC - A member of the LYDC must be a citizen of the Philippines, a resident of the city for not less than one year immediately preceding the day of her/his election to the LYDC. She/He should be at least fifteen (15) years, but not more than thirty (30) years of age on the day of her/his election at the council, able to read and write Filipino, English, or the local dialect, and must not have been convicted by final judgment of any crime involving moral turpitude.

SECTION 3. - QUALIFICATIONS OF YOUTH ORGANIZATIONS (YO'S) AND YOUTH-SERVING ORGANIZATIONS (YSO'S) - Only registered Youth Organizations (YO's) and Youth Serving Organizations (YSO's) with a minimum number of (10) members in good standing and which are operating in the City of Malolos shall be allowed to participate in the LYDC election.

For purposes of this Ordinance, YO's and YSO's shall mean:

- a. **YOUTH ORGANIZATION** - refers to an organization with members in good standing entirely composed of the youth, whose ages range from fifteen (15) to thirty (30) years old with a core advocacy that serves the youth.
- b. **YOUTH SERVING ORGANIZATION** - refers to registered organization with members in good standing whose principal programs, projects and activities are youth related and youth-oriented and whose compositions are not limited to the youth.

SECTION 4. - LOCAL REGISTRATION AND VERIFICATION OF YOUTH AND YOUTH-SERVING ORGANIZATIONS

- A. The Local Youth Development Office (LYDO) shall register and verify YOs and YSOs operating in the city. In the absence of a Local Youth Development Office (LYDO), the City Mayor shall designate existing personnel for the local government unit, who shall register these organizations.
- B. To ensure that all YOs and YSOs participating in the LYDC are enlisted in the Youth Organizations' Registration Program (YORP) of the National Youth Commission (NYC), the LYDO shall facilitate the issuance of an NYC YORP Unique Registration Number (URN) for every locally registered and verified YOs and YSOs. Hence, pertinent registration documents of all YOs and YSOs that have underwent local registration and verification under the LYDO shall be submitted to the NYC YORP Secretariat through the YORP Online Hub [yorpnyc.org.ph/register.ph].
- C. The following registration documents shall be submitted by any Yo's or YSO's who seeks registration before the LYDO:
 - 1. Official Registration Form;
 - 2. Directory of Officers and Advisers;
 - 3. List of Members in good standing;
 - 4. Copy of Constitution and By-laws, which should indicate the age and scope of membership; and
 - 5. Endorsement for Certification from Appropriate Authority.

SECTION 5. - MANNER OF ELECTION OF THE MEMBERS OF THE CITY LOCAL YOUTH DEVELOPMENT COUNCIL - The election of the members of the City Local Youth Development Council (CYLDC) shall be conducted within forty-five (45) days) after the Sangguniang Kabataan (SK) Elections.

This City Ordinance adopts the Guidelines on the Convening and Election of members of the Local Youth Development Council promulgated by the National Youth Commission (NYC) and the guidelines set for under DILG Memorandum No. 2018-124.

SECTION 6. - SEPARABILITY CLAUSE - If any provision or part of this Ordinance is declared invalid or unconstitutional, the other parts or provisions thereof shall remain valid and effective.






Section 8. - EFFECTIVITY - This Ordinance shall take effect 15 days upon approval and upon compliance with Section 59 (c) of RA 7160.


