### CITY ORDINANCE NO. 53-2020

AN ORDINANCE AMENDING CITY ORDINANCE NO. 15-2018 ALSO KNOWN AS THE "CITY OF MALOLOS CONSUMER'S PROTECTION ORDINANCE" TO PROVIDE PENALTIES FOR VIOLATION THEREOF AND FOR OTHER PURPOSES.

### EXPLANATORY NOTES

**WHEREAS**, Republic Act No. 7394 also known as Consumer's Act of the Philippines penalized the selling, marketing and distribution of adulterated products, overpriced goods and material manifestation and fraud in relation to the goods or services being sold to the public;

**WHEREAS**, records show that more than 50 weighing scale was confiscated in the Malolos Public Market (MAPUMA) for being defective;

**WHEREAS**, it is the primary duty of the City Government of Malolos to protect the interest of its constituents and its clientele in the Malolos Public Market and to other private markets and establishments;

**WHEREAS**, section 16 of Republic Act No. 7160 also known as the Local Government Code of 1991 provides that it is the duty of every Local Government Unit (LGU) to provide programs and projects that will redound to the general welfare of its constituents;

Be it ordained by the members present

**SECTION 1. - PROHIBITION** - It is unlawful for any person, natural or juridical, to use defective weighing scale in their business in any establishment within the territorial jurisdiction of the City of Malolos.

For the Malolos Public Market, it is hereby mandated that the Market Supervisor IV (Market Master) shall conduct surprise inspection to all vendors/stalls at least once a week to check their weighing scale.

SECTION 2. - PENALTY. For the effective and efficient implementation of the City Ordinance No. 15-2018, it is hereby mandated to penalize any person, natural or juridical, who violated the provisions therein as follows:

DEFECTIVE WEIGHING SCALE:

- 1<sup>ST</sup> OFFENSE : Confiscation of the weighing scale and fine of Php1,000.00;
- 2<sup>ND</sup> OFFENSE : Confiscation of the weighing scale and fine of Php2,000.00;
- 3<sup>RD</sup> OFFENSE : Confiscation of the weighing scale and fine of Php3,000.00 and/or revocation of Business Permit and/or forfeiture/revocation of his/her right over his/her stall.

SECTION 3. - SEPARABILITY CLAUSE - If for any reason, any section or provision of this Ordinance shall be held as unconstitutional or invalid by competent authority, such judgement or action shall not affect or impair the other sections or provisions thereof.
