CITY ORDINANCE NO. 73-2020

**AN ORDINANCE ALLOWING RICHWORLD AIRE AND TECHNOLOGIES CORPORATION FOR THE CONSTRUCTION, INSTALLATION AND OPERATION OF GLOBE TELECOMMUNICATION FACILITIES AT BARANGAY BANGKAL, CITY OF MALOLOS, BULACAN.**

WHEREAS, Richworld Aire and Technologies Corporation, requested the Sangguniang Panlungsod the authority to install, operate and maintain integrated Globe telecommunication facilities at Bangkal, City of Malolos;

WHEREAS, their operation will satisfy the needs of the City residents for fixed, cellular telephones and other telecommunication services to supplement the services being rendered by other existing telecommunication companies;

WHEREAS, the Sangguniang Panlungsod of Malolos is empowered by the Local Government Code of 1991 to approve ordinance which shall ensure the efficient and effective delivery of basic services and facilities;

NOW THEREFORE, be it ordained by the Sangguniang Panlungsod in session duly assembled, that;

SECTION 1. - RIGHTS GRANTED - The Sangguniang Panlungsod of Malolos grants the rights for the construction, installation and operation of Globe telecommunication facilities, to Richworld Aire and Technologies Corporation, the said is located at Barangay Bangkal, City of Malolos.

SECTION 2. - COMPLIANCE WITH THE EXISTING LAWS - The authority granted herein is subject to the grantee's compliance with the terms and conditions imposed by its congressional franchise and its provisional authority granted by National Telecommunications Commission (NTC).

SECTION 3. - DEPOSIT AND GUARANTEE - GLOBE TELECOM INC. thru Richworld Aire and Technologies Corporation shall file with the Treasurer's Office a surety bond in the amount of Php500,000.00 to answer for damages to third persons and/or property that may be incurred as a result of construction, installation, operation and maintenance of its telecommunication facilities and to insure faithful compliance of its obligation under this and all other existing Ordinance of this City.

SECTION 4. - PROVISION OF SECURITY GUARD ON SITE - The grantee shall provide security guard on the site of each facility. The said shall be guarded twenty four hours a day.


SECTION 5. - REVOCATION - Violation of any provision of this Ordinance and all other laws related hereto is sufficient to revoke the authority herein granted.


SECTION 6. - EFFECTIVITY - This Ordinance shall take effect upon its approval.
