CITY ORDINANCE NO. 89-2020

A CITY ORDINANCE ADOPTING AND APPROVING THE 2020 NEW ORGANIZATIONAL STRUCTURE AND STAFFING PATTERN (OSSP) OF THE CITY GOVERNMENT OF MALOLOS, APPROPRIATING FUNDS THEREFORE AND FOR OTHER PURPOSES.

EXPLANATORY NOTE

WHEREAS, the Sangguniang Panlungsod through Kapasyahang Panlungsod Blg. 246-2020 authorized the Honorable City Mayor Gilbert T. Gatchalian to reorganize the structure and staffing pattern of the City Government of Malolos;

WHEREAS, on November 06, 2020, the City Mayor issued Executive Order No. 61, Serie of 2020 creating the Management Study Group (MSG) to conduct research and study on the present staffing pattern and to make recommendations for the new staffing pattern of the City Government;

WHEREAS, the said Executive Order was duly submitted to the Office of the Provincial Governor on November 06, 2020 for mandatory review as mandated under Section 30 of Republic Act No. 7160 also known as the Local Government Code of 1991;

WHEREAS, Section 76 of the same code provides, Every Local Government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its services requirements and financial capability subject to the minimum standards and guidelines prescribed by the Civil Service Commission;

WHEREAS, Republic Act No. 6656 also known as the "An Act to Protect the Security of Tenure of Civil Service Officers and Employees in the Implementation of Government Reorganization provides for the same power;

WHEREAS, the submitted proposed 2020 New Organizational Structure and Staffing Pattern (OSSP) introduces changes by eliminating the duplication of functions on Civil Service Workforce of this Local Government Unit, rectification on the positions affected by the 2012 Reorganization and the observance of the stringent procedures in the preparation of the new staffing pattern that reflect the needs of the city in terms of workforce and manpower;

WHEREAS, Section 16 of Republic Act No. 7160 mandates the promotion of the general welfare of every citizens through the implementation of programs and projects;

NOW THEREFORE, on motion of **Hon. Nino Carlo C. Bautista,** duly seconded by members present,

BE IT ORDAINED, by the City Council of Malolos in session assembled the following, to wit:

SECTION 1. - TITLE - This City Ordinance shall be known and be cited as the "2020 Organizational Structure and Staffing Pattern (OSSP) of the City of Malolos".

SECTION 2. - ADOPTION AND APPROVAL - It is hereby adopted and approved the new 2020 Organizational Structure and Staffing Pattern (OSSP) of the City of Malolos in toto.

SECTION 3. - The Local Placement Committee may promulgate its Implementing Rules and Regulations for the implementation of the reorganization and Organizational Structure and Staffing Pattern (OSSP) of the City of Malolos herein.

SECTION 4. - APPROPRIATIONS - The Local Chief Executive through the Local Finance Committee is hereby mandated to allocate sufficient funds to implement this Ordinance subject to the limitations set forth by law on Personal Services Budgetary Allocations.

Section 5.- EFFECTIVITY - This ordinance shall take effect upon approval.
