## CITY ORDINANCE NO. 93-2020

AN ORDINANCE AMENDING SECTION 20 OF CITY ORDINANCE NO. 31-2020, ALSO KNOWN AS THE COVID-19 PREVENTION AND CONTROL ORDINANCE TO SET THE DEADLINE FOR THE PAYMENT OF LOCAL TAXES TO DECEMBER 29, 2020 WITHOUT PENALTY OR SURCHARGES IN THE CITY OF MALOLOS.

WHEREAS, the City Council passed and adopted City Ordinance No. 31-2020 also known as the COVID-19 Prevention and Control Ordinance in response to the pandemic caused by COVID-19;

WHEREAS, on March 9, 2020, the Philippines declared the rapid spread of the Novel Corona Virus Disease (COVID-19) as a public health emergency;

WHEREAS, on March 11, 2020, the World Health Organization has characterized the spread of the disease as a pandemic as it continues to spread throughout;

WHEREAS, on March 12, 2020, the Inter-Agency Task Force (IATF) for the Management of Emerging Infectious Diseases of the National Government issued Joint Resolution No. 11 for the management of the COVID-19, providing for strict social distancing guidelines, including suspension of classes, prohibition on mass gatherings, community quarantine, and restriction of domestic and international travel;

WHEREAS, on 12 February, 2020, the Office of the City Mayor has issued Executive Order No. 4 Series of 2020 - An Executive Order Creating the Novel Coronavirus Task Force of the City of Malolos, Bulacan to contain and prevent COVID-19;

WHEREAS, Proclamation No. 1021 dated 16<sup>th</sup> of September 2020, extending the period of the State of Calamity throughout the Philippines due to Corona Virus Disease 2019 declared under Proclamation No. 929, S. 2020 shall be extended effective 13 September 2020 to 12 September 2021, unless earlier lifted or extended as circumstances may warrant;

WHEREAS, Department Circular No. 003.2020 dated 23 October, 2020, issued by Department of Finance, on mandatory extension of deadlines for the payment of taxes, fees and charges of Local Government Units (LGUs), pursuant to Section 4 (tt) of Republic Act No. 11494, or the "Bayanihan To Recover as One Act";

WHEREAS, despite these interventions, the disease continues to spread rapidly in the country;

WHEREAS, the City Government of Malolos recognizes that COVID-19 is a public health emergency with wide-ranging social, political, and economic repercussions, and that responding to the City of Malolos's COVID-19 situation is imbued with public

On motion of Hon. Noel G. Pineda, duly seconded by Members present,

NOW, THEREFORE, BE IT ORDAINED, by the Sangguniang Panlungsod of Malolos, in session that:

SECTION 1. - The provision under Section 20 of City Ordinance No. 31-2020 is hereby amended as follows:

'SECTION 20. - Deadline of Payment of Local Taxes - The deadline for payment of local taxes including quarterly business tax, quarterly real property tax, and similar taxes, including tricycle franchise fees including other regulatory fee to transport sectors, falling due during after the Declaration of State of Calamity is hereby extended until the  $29^{\rm th}$  of December, 2020'.

SECTION 2. - SEPARABILITY CLAUSE - If for any reason, any provision of this Ordinance is declared unconstitutional or invalid, the remaining provisions not affected thereby shall continue to be in full legal force and effect.

SECTION 3. - EFFECTIVITY CLAUSE - This Ordinance shall take effect immediately upon approval.
