CITY RESOLUTION NO 07-2021

A CITY RESOLUTION AMENDING CITY RESOLUTION NO. 71-2019, ALSO KNOWN AS THE INTERNAL RULES OF PROCEDURE (IRP) OF THE SANGGUNIANG PANLUNGSOD OF THE CITY OF MALOLOS, AMENDING CITY RESOLUTION NO.59-2020 AND REPEALING CITY RESOLUTION NO.116-2020, PROVIDING FOR THE NEW COMPOSITIONS OF THE STANDING COMMITTEES OF THE SANGGUNIANG PANLUNGSOD.

WHEREAS, on the noon of June 2019, the Newly Elected Members of the City Council assumed their respective positions for 2019-2022 term of office;

WHEREAS, Section 50 of Republic Act No. 7160 also known as the Local Government Code of 1991 provides, that on the First Regular Session following the election of its members and within ninety (90) days thereafter, the sanggunian concerned shall adopt or update its existing rules of procedure;

WHEREAS, Section 50 (b) of the same code also provides the organization of the sanggunian and the election of its officers as well as the creation of Standing Committees which shall include, but shall not be limited to, the committees on appropriations, women and family, human rights, youth and sports development, environmental protection, and cooperatives; the general jurisdiction of each committee; and the election of the chairman and members of each committee;

WHEREAS, the SangguniangPanlungsod passed City Resolution No. 71-2019 as amended by City Resolution Nos. 59-2020, 92-2020, 116-2020 and 211-2020, providing for the Internal Rules of Procedure.

SECTION 1.- The provision of Section 14 of Rule VII (Sessions) of City Resolution No. 71-2019 and City Resolution No. 59-2020 is hereby amended as follows:

"Section 14. - Regular Sessions - The Regular Session of the SangguniangPanlungsod shall be held every Thursday at exactly 9:00 in the morning at the New Session Hall located at the 5th Floor of the New City Hall of the City Government, Bulihan, City of Malolos, or at such place as may be decided upon in the immediately preceding session. If a holiday falls on a Thursday or in any other day as approved by the Majority of all the members present."

SECTION 2.- The provision of Section 29 paragraph (i) and (cc) of City Resolution No. 71-2019 is hereby mandated as follows:

"Section 29 xxx paragraph (i) - Committee on Land Use - Matters related to the preparation of a comprehensive master plan for the physical, economic, socio-cultural, religious and other aspects of the present and future development of the City; classification, use, possession and ownership of lands; determination of boundaries, buildings and structures; matters related to zoning, subdivision, real estate and acquisition of land estates; matters pertaining to the approval of development permits after full compliance with National Laws and Ordinances.



(cc) - Committee on Review - Matters related to the assessment/evaluation of pending local legislative transactions to wit: proposed resolutions and ordinances, referral cases; such other matters which are needing immediate attention and/or consideration by the SangguniangPanlungsod; matters pertaining to the grant and approval of Public-Private-Partnership (PPP) agreements.

SECTION 3.- City Resolution No. 116-2020 is hereby repealed. The New Composition of the Standing Committees is hereby adopted. Attached herewith is the copy of the New Composition of the Standing Committees.

COMMITTEE ON RULES AND DECORUM (Lupon sa Alituntunin) - The committee shall have overall jurisdiction on all matters relating to the Rules and Procedures of the Sanggunian, calendar, agenda, order and manner of transacting business in the Regular Session, Special Sessions of the Sanggunian, creation and re-organization of committees, the codification of ordinances, resolutions, upgrading of the Rules of Procedures, and the disorderly behavior and privileges of its members, as well as matters relating to the legal aspects of action taken by, or submitted to, the Sanggunian.

SECTION 4.- The Presiding Officer has a maximum of three (3) days from the adoption and approval of legislative enactments such as City Resolutions and Ordinances to sign or affix his/her signature. Failure on his part, the approved City Resolution or Ordinance shall be forwarded to the Office of the City Mayor by the Sanggunian Secretariat even without his signature. The SangguniangPanlungsod Secretariat shall certify that the 3-day period has already lapsed.

SECTION 5.- RECORDING AND SAFEKEEPING OF AUDIO AND VIDEO RECORDINGS - The SangguniangPanlungsod Regular or Special Sessions, meetings and hearings shall be recorded both by Video and Audio recordings. It is hereby designated the Office of the SangguniangPanlungsod Secretariat, the City Information Office (CIO) and a representative from the Non-Government Organization (NGO) which to be identified by the Committee on Rules from time to time to cover the sessions, meetings and hearings.

The official (raw) recordings shall be under the control and supervision of the SangguniangPanlungsod Secretariat and shall be available to the public for scrutiny.

SECTION 6.- No changes or any modification in the Internal Rules of Procedure (IRP) of the SangguniangPanlungsodngMalolosshall be allowed within the next 12 months from the effectivity of this City Resolution. The vote of majority of all the Members of the Sangguniang Panlungsod (7 affirmative votes) is necessary for any changes or modifications after the period stated herein.

SECTION 7.- SEPARABILITY CLAUSE - If, for any reason, any section or provision of this City Resolution is disallowed or declared invalid by proper authorities, other sections, or provisions hereof that are not affected thereby shall continue to be in full force and effect.

SECTION 8.- EFFECTIVITY - This City Resolution shall take effect immediately upon approval.






