CITY RESOLUTION NO. 08-2021

A CITY RESOLUTION APPROVING AND ADOPTING THE ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY GOVERNMENT OF MALOLOS FOR FISCAL YEAR 2021 IN THE AMOUNT OF TWO BILLION SIX HUNDRED SEVENTY THREE MILLION EIGHT HUNDRED THOUSAND TWO HUNDRED FORTY FIVE PESOS AND 78/100 (Php. 2,673,800,245.78) ;

WHEREAS, Section 16 of Republic Act No. 7160 also known as the Local Government Code of 1991 mandates that every Local Government Units (LGU's) shall formulate programs and projects that will redound to the benefits of its constituents and promote the general welfare of every person;

WHEREAS, the Honorable City Mayor Engr. Gilbert T. Gatchalian through the Local Finance Committee submitted the proposed Annual Investment Program (AIP) of the City Government of Malolos last October 15, 2020 to the Sangguniang Panlungsod;

WHEREAS, Article 182 of Rule XXIII of Implementing Rules and Regulations of Republic Act No. 7160 mandates every Local Government Units (LGUs) shall pass and adopt a comprehensive multi-sectoral development plan to be initiated by the Local Development Council (LDC) and approved by the concerned sanggunian;

WHEREAS, the Department of Interior and Local Government - National Economic Development Authority - Department of Budget and Management - Department of Finance (DILG-NEDA-DBM-DOF) Joint Memorandum Circular (JMC) No. 1, Series of 2016 defines the Annual Investment Program (AIP) as the annual slice of the Local Development Investment Program (LDIP), which constitutes the total resource requirements for all programs, projects and activities (PPAs) of the annual capital expenditure and regular operating requirements of the local government unit;

WHEREAS, the approval and adoption of the Annual Investment Program (AIP) is a pre-requisite and a condition sine qua non before the enactment of the Annual Appropriation Ordinance;

WHEREAS, the proposed Annual Investment Program (AIP) of the City for 2021 includes programs and projects necessary to combat the spread of the pandemic caused by Covid-19, anti-poverty alleviation programs, environmental protection programs, socio-economic programs, infrastructure development among others;

RESOLVED as it is hereby resolved to approve and adopt the Annual Investment Program (AIP) of the City Government of Malolos for fiscal year 2021 in the amount of TWO BILLION SIX HUNDRED SEVENTY THREE MILLION EIGHT HUNDRED THOUSAND TWO HUNDRED FORTY FIVE PESOS AND 78/100 (Php. 2,673,800,245.78).




