WHEREAS, Article 182 (d) (ii) of the Implementing Rules and regulations of RA 7160 mandates the Local Development Council (LDC) to formulate medium-term and annual public investment programs;

WHEREAS, the Department of Interior and Local Government - National Economic Development Authority - Department of Budget and management - Department of Finance (DILG-NEDA-DBM-DOF) Joint memorandum Circular (JMC) No. 1, Series of 2016 defines the Annual Investment program (AIP) as the annual slice of the Local Development Investment Plan (LDIP), which constitutes the total resource requirements for all programs, projects and activities (PPAs) of the annual capita expenditure and regular operating requirements of the local government unit;

WHEREAS, the City of Malolos Development Council (CMDC) approved the Local Development Investment Program (LDIP) 2020-2022 and its updates thru CMDC Resolution No. 05-2019 dated November 19, 2019;

WHEREAS, the City of Malolos Development Council (CMDC) approved the Annual Investment Program (AIP) and the allocation of the 20% Development Fund for the year 2018 and 2019 thru CMDC Resolution Nos. 01-2017, 03-2018 respectively;

WHEREAS, a special trust fund accrued from the unexpected balance of the Local Disaster Risk Reduction and management Fund (LDRRMF) Fiscal Year 2019 amounting to Php30,026,094.65 were appropriated for food assistance and other relief goods for affected families thru the City Disaster Risk Reduction and Management Council (CDRRMC) Resolution No. 02-2020;

WHEREAS, Section 16 of R.A. 7160 mandates the implementation of projects and programs by the Local Government Units (LGUs) that will redound to the general welfare of its constituents;

WHEREAS, the City Mayor thru the Office of the City Planning and Development Office, respectfully requested the City Council to adopt and approved the City of Malolos Development Council Resolution No. 04-2020, which was approved on April 13, 2020 by the Local Development Council during its general meeting;

WHEREAS, the law provides that any amendments to the Comprehensive Development Plan (CDP), Local Development Investment Program (LDIP) and Annual Investment Program (AIP), the Local Development Council shall approved thru a Board Resolution any changes or updates to the aforementioned;

WHEREAS, Art. 182 of Rule XXIII mandates every Local Government Units (LGUs) to have a comprehensive multi-sectoral development plan to be initiated by the Local Development Council (LDC) and approved by the concerned Sanggunian;

WHEREAS, there is a need for the passage of a Supplemental Budget;






