GATCHALIAN TO ENTER AND SIGN IN BEHALF OF THE CITY GOVERNMENT OF MALOLOS INTO A MEMORANDUM OF UNDERSTANDING (MOU) WITH THE MANILA ELECTRIC COMPANY (MERALCO) FOR ITS ELECTRIC SERVICE FOR THE ISSUANCE OF THE ELECTRONIC CERTIFICATE OF FINAL ELECTRICAL INSPECTION (CFEI) PERMIT.

WHEREAS, MERALCO is a private electric distribution utility operating in Metro Manila, and the Provinces of Rizal, Cavite, Bulacan, and portions of Batangas, Laguna, Quezon, and Pampanga by virtue of its legislative franchise, Republic Act No. ("RA") 9209;

WHEREAS, MERALCO's mission is to provide its customers the best value in and timely delivery of energy, products and services and CITY OF MALOLOS mission is to deliver basic services to its constituents;

WHEREAS, one of the requirements for the energization of buildings and others structure is the physical copy of the Certificate of Final Electrical Inspection or Permit for Temporary Service Connection to be issued by the OFFICE OF THE BUILDING OFFICIAL to an application for electric service;

WHEREAS, to avoid any alternations and/or lost CEI and to facilitate the immediate release of the connection work order pursuant to the Ease of Doing Business (EODB) Act, CITY OF MALOLOS shall submit a list of approved CEIs to MERALCO through electronic mail;

WHEREAS, the list of applicants shall be considered by CITY OF MALOLOS as list of applicants in the processing of its request for wirig permit and CEI;


WHEREAS, the list of approved CEIs shall be considered by **MERALCO** as valid requirement in the processing of its request for energization;


WHEREAS, the same seeks to help in the expansion and growth of CITY OF MALOLOS communities, and enable it to be better respond to the challenges of urbanization;


