WHEREAS, the Department of Social Welfare and Development's mission is to lead in the formulation of social welfare and development policies and programs for and with the poor, vulnerable and disadvantaged;

WHEREAS, in line with its mission, the DSWD recognizes the valuable role, participation and engagement of the Local Government Unit as they lawfully exercise powers necessary and appropriate for efficient and effective delivery of programs and services for the general welfare of their constituents;

WHEREAS, the City of Malolos as Local Government Unit has the following capacity and powers to grant the needed programs and services among others are:

- Social welfare services which include programs and projects designed for children and youth welfare of the family, community women, elderly and disable persons; community-based rehabilitation programs for vagrants, beggars, street children, scavengers, juvenile delinquents, and victims of drug abuse; livelihood and other pro-poor projects; nutrition services; and family planning services;
- Health Services which include the implementation of programs and projects on primary health care, maternal and child care and communicable and non-communicable disease control services; access to secondary and tertiary health services; purchase of medicines, medical supplies and equipment needed to carry out the services herein enumerated;
