WHEREAS, on July 11, 2019, the Sangguniang Panlungsod adopted City Resolution No. 71-2019 also known as the New Internal Rules of Procedure of the Sangguniang Panlungsod of the City of Malolos;

WHEREAS, amendment to the aforementioned rule is allowed under Section 50 of R.A. 7160 and under Section 73 of Rule XXI of City Resolution No. 71-2019;

BE IT RESOLVED, as it is hereby resolved, to amend Internal Rules of Procedure of the Sangguniang Panlungsod 2019-2022 (Rule IX, Section 27) and Section 2 of the City Resolution No. 92-2020 and shall be read as follows:

'Section 1. - Creations of Standing Committee - The Sanggunian shall create standing committee each composed of a Chairman, Vice-Chairman and three (3) members. The standing committees may from time to time be reorganized by a majority vote of members present'.
