A CITY RESOLUTION RESPECTFULLY ENDORSING THE PROPOSED PROJECT OF THE CITY OF MALOLOS FOR THE CONSTRUCTION OF a) BRIDGE AT SITIO BIGA, DAKILA, b) UPGRADING OF ROAD AND DRAINAGE AT KABIHASNAN ST. CANIOGAN AND c) INSTALLATION OF STREET LIGHTS IN DIVERSION ROAD, MABOLO AND STO. CRISTO PART OF THE PROJECTS LISTED IN THE LDIP 2020-2022 AND AIP 2021 TO THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM) THROUGH THE OFFICE OF SECRETARY WENDEL E. AVISADO FOR THE LOCAL GOVERNMENT SUPPORT FUND-ASSISTANCE TO CITIES (LGSF-AC) IN THE FY 2021 GENERAL APPROPRIATIONS ACT (GAA), REPUBLIC ACT NO. 11518.

WHEREAS, Section 16 of Republic Act No. 7160 also known as the Local Government Code of 1991 mandates that every local government unit shall pursue programs and projects for the general welfare of its constituents;

WHEREAS, Section 17 of the same likewise provides that LGU's shall establish tree parks as well as tourist attractions, people's park, road connections, bridges and the likes for the benefit of its constituents;

WHEREAS, the City Government of Malolos is firm to its commitment in providing basic services and facilities for the enjoyment of every Maloleños and one of its priorities are the a) Bridge at Sitio Biga, Dakila, b) Upgrading of road and drainage at Kabihasnan St. Caniogan and c) Installation of street lights in Diversion Road, Mabolo and Sto. Cristo;

WHEREAS, in the approved Annual Investment Program (AIP) for 2021 and the Local Development Investment Program (LDIP) for 2020-2022 of the City of Malolos, the a) Bridge at Sitio Biga, Dakila in the amount of Php10,000,000.00, b) Upgrading of road and drainage at Kabihasnan St. Caniogan in the amount of Php9,000,000.00 and c) Installation of street lights in Diversion Road, Mabolo and Sto. Cristo in the amount of Php2,500,000.00 was included and adopted by the City Council;

WHEREAS, the City has a pending request for LGSF-AC for Fiscal Year 2021 before the DBM in the amount of Php21,500,000.00 for the realization and completion of this proposed project;




