**A RESOLUTION AUTHORIZING THE CITY MAYOR ENGR. GILBERT T. GATCHALIAN, TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) ON BEHALF OF THE CITY GOVERNMENT OF MALOLOS WITH THE OFFICE OF THE PRESIDENT TO REQUEST AND ACCEPT THE FINANCIAL ASSISTANCE WORTH FIVE MILLION PESOS (P5,000,000.00) TO BE USED FOR THE CITY'S REHABILITATION EFFORTS FOR THE DAMAGES BROUGHT ABOUT BY TYPHOON ULYSSES.**

**WHEREAS**, Article I, Section 25 (c) of Republic Act No. 7160 states, otherwise known as the Local Government Code of 1991 so provides that the President may, upon request of the local government unit concerned, direct the appropriate national agency to provide financial, technical, or other forms of assistance to the Local Government Unit. Such assistance shall be extended at no extra cost to the local government unit concerned";


**WHEREAS**, Section 17 of the same Code states that the National Government or the next higher level of local government unit may provide or augment the basic services and facilities assigned to a lower level of local government unit when such services or facilities are not made available or, if made available, are inadequate to meet the requirements of its inhabitants;






**WHEREAS**, the assistance shall be used to cater and address the immediate needs of the people affected by the typhoon as well as to implement long term solution and provide future evacuation of people living in the hazard prone areas in LGU-Malolos;

**WHEREAS**, the City was hit by typhoon Ulysses that caused damage to properties. The City aims to establish Evacuation Centers in strategic locations to cater the vulnerable families in times of calamities;

**WHEREAS**, Section 16 of RA 7160 mandates that every Local Government Unit (LGU) shall implement programs and projects that will promote general welfare of its constituents;

**WHEREAS**, Section 22 (c) also provides "(c) Unless otherwise provided in this Code, no contract may be entered into by the Local Chief Executive in behalf of the Local Government Unit without prior authorization by the Sanggunian concerned;






