#### CITY RESOLUTION NO. 128-2021

A CITY RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ENGR. GILBERT T. GATCHALIAN TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY GOVERNMENT OF MALOLOS WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL OFFICE III FOR THE IMPLEMENTATION OF SUPPLEMENTARY FEEDING PROGRAM (SFP) IN THE CITY OF MALOLOS.

WHEREAS, Section 16 of Republic Act No. 7160 also known as the Local Government Code of 1991 mandates that every Local Government Units (LGU's) shall formulate programs and projects that will promote the general welfare of its constituents;

WHEREAS, the Honorable City Mayor Engr. Gilbert T. Gatchalian requested the approval and grant of authority to enter into a Memorandum of Agreement (MOA) in behalf of the City Government of Malolos with the Department of Social Welfare and Development (DSWD) for the implementation of the Supplementary Feeding Program (SFP) in this city;

WHEREAS, the Supplementary Feeding Program (SFP) is the provision of food in addition to the regular meals to target children ages 2-5 years old enrolled in the Child Development Center (CDCs) and Supervised Neighborhood Play (SNPs) as part of the DSWD's contribution to the Early Childhood Care and Development (ECCD) program of the government;

WHEREAS, on September 16, 2020, the President issued Proclamation No. 1021 (s.2020) extending the period of the State of Calamity throughout the Philippines until September 21, 2021; The LGUs outside of Luzon shall continuously imposed localized community quarantine in their areas of jurisdiction consistent with the parameters of the pertinent IATF Resolution in lieu of the new variant of the SARS-CoV-2 (B.1.1.7 or VUI 2020/12/01) spreading in the United Kingdom of Great Britain and Northern Ireland (United Kingdom) and another variant identified in South Africa (501.V2);

WHEREAS, Republic Act (R.A.) No. 11469, otherwise known as the "Bayanihan to Heal As One Act", directed the provision of unified interventions from the whole-of-government including provision of safety nets to curtail the impact of health and economic emergencies to all vulnerable sectors which include children of formative years;

**WHEREAS**, Section 4 (v) sub-item (8) of R.A. No. 11469 has identified the SFP as one of the priority programs necessary or beneficial in order to address COVID-19 emergency;

KIRK LOUIS NICOL CITY COUNCILOR WHEREAS, noting the limitation in the purchasing power of most families, SFP implementation during the implementation of community quarantine shall assist in addressing the issue of hunger and food security among Filipino children and prevent regression of the current nutritional status of the beneficiaries.

WHEREAS, local government units (LGUs), as partners of the DSWD in the expeditious delivery of the social amelioration program, shall also assist in the implementation of SFP;

WHEREAS, fund transfer to LGUs is identified as the best scheme to fast track the implementation of the program to the beneficiaries, and shall be an interim solution for the current emergency or crisis situation due to COVID-19;

On motion of  $\operatorname{\textbf{Hon.}}$  Nino  $\operatorname{\textbf{Carlo}}$  C.  $\operatorname{\textbf{Bautista}}$ , duly seconded by all the members present,

RESOLVED AS IT IS HEREBY RESOLVE to grant authorization to the Honorable City Mayor Engr. Gilbert T. Gatchalian to enter and sign on behalf of the City Government into a Memorandum of Agreement (MOA) with the Department of Social Welfare and Development (DSWD) Regional Office III for the implementation of Supplementary Feeding Program (SFP) in the City of Malolos.
