CITY RESOLUTION NO. 132-2020

A CITY RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, ENGR. GILBERT T. GATCHALIAN, TO SIGN AND ENTER INBEHALF OF THE CITY GOVERNMENT OF MALOLOS INTO A CONTRACT OF SERVICE (MEMORANDUM OF AGREEMENT) WITH THE PHILIPPINE LONG DISTANCE TELECOMMUNICATIONS (PLDT) FOR ITS IGATE PREMIUM SERVICES TO PROVEVIDE INTERNET SERVICES AND CONNECTIVITY TO THE NEW MALOLOS CITY HALL LOCATED AT BARANGAY BULHAN, CITY OF MALOLOS.

WHEREAS, Section 16 of Republic Act No. 7160 also known as the Local Government Code of 1991 mandataes the implementation of projects and programs by the Local Government Units (LGUs) that will redound to the general welfare of its constituents;

WHEREAS, Kautusang Panlungsod Blg. 23-2020 was enacted by the Honorable City Council authorizing the transfer of the seat of power of the City Government of Malolos from its present location to the New City Hall located at Barangay Bulihan, City of Malolos.

WHEREAS, the Honorable City Mayor through a letter (Certified Urgent) asked for an authorization to enter into a contract of service with PLDT for its IGATE Premium services;

WHEREAS, the primary objective of the City Government of Malolos is to give effective and efficient delivery of services to its constituents with the use of technological advancement in its transactions;

WHEREAS, Section 22 (c) of Republic Act No. 7160 also known as the Local Government Code of 1991 provides that before a Chief Executive may enter and sign into any contract in behalf of the Local Government Unit concerned, there is a need for a prior authorization from the Sangguniang Panlungsod.
