CITY RESOLUTION NO. 149'-2021

A CITY RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR - ENGR. GILBERT T. GATCHALIAN TO ENTER AND SIGN ON BEHALF OF THE CITY GOVERNMENT OF MALOLOS INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE OFFICE OF CIVIL DEFENSE (OCD) REGIONAL OFFICE III, DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT OFFICE (DSWD) REGIONAL OFFICE III, DEPARTMENT OF HEALTH (DOH) REGIONAL OFFICE III AND THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) - REGIONAL OFFICE III FOR THE IMPLEMENTATION, OPERATION AND MAINTENANCE OF THE EVACUATION CENTER PROJECT OF DPWH LOCATED IN THE CITY OF MALOLOS GOVERNMENT CENTER.

WHEREAS, Section 16 of Republic Act No. 7160 also known as the Local Government Code of 1991 mandates that every local government units shall formulate programs and projects that will promote the general welfare of its constituents;

WHEREAS, on May 27, 2010, Republic Act No. 10121, otherwise known as the Philippine Disaster Risk Reduction and Management Act of 2010 was passed into law which aims to strengthen the country's disaster risk reduction and management system;

WHEREAS, the government has to mainstream disaster risk reduction and climate change in development processes such as policy formulation, socioeconomic development planning, budgeting, and governance, particularly in the areas of environment, agriculture, water, energy, health, education, poverty reduction, land-use and urban planning and public infrastructure and housing, among others;

WHEREAS, the government recognizes that the use of schools as evacuation centers/areas displace the students from their learning centers;

WHEREAS, the government recognizes and strengthens the capacities of local government units (LGUs) and communities in mitigating and preparing for, responding to, and recovering from the impact of disasters;

WHEREAS, the Office of the Civil Defense (OCD) through its Regional Disaster Risk Reduction and Management Council (RDRRMC), has identified six (6) LGUs in each region where the Regional Evacuation Center Project is to be constructed and implemented and one of those is the City of Malolos, Bulacan;

WHEREAS, the Department of Social Welfare and Development Office (DSWD) as a cluster lead of the Camp Coordination and Camp Management, as stated in the National Disaster Response Plan, aims to provide timely and well-coordinated humanitarian assistance and augmentation support in the management of the evacuation center;

WHEREAS, the City of Malolos is willing to accept the said project for its implementation, operation and maintenance;

WHEREAS, the City of Malolos is one of the most vulnerable cities in the Province of Bulacan and in Region III in terms of the adverse effects of Climate Change and Natural Disasters such as typhoon, flooding and storm surge;

RESOLVED, as it is hereby resolved to authorize the Honorable City Mayor - Engr. Gilbert T. Gatchalian to enter and sign in behalf of the City Government of Malolos into a Memorandum of Agreement (MOA) with the Office of the Civil Defense (OCD) Regional Office III, Department of Social Welfare and development Office (DSWD) Regional Office III, Department of Health (DOH) Regional Office III and the Department of Public Works and Highways (DPWH) - Regional Office III for the implementation, operation and maintenance of the Evacuation Center project of DPWH located in the City of Malolos Government Center.
