


WHEREAS, on 25 August 2021 Department of Budget and Management (DBM) approved Budget Circular No. 2021-2 with the main purpose to prescribe the rules and regulations on the upgrading of the previous Nurse II positions by one (1) Salary Grade, as well as to provide the administrative processes for the retention of the position titles of Nurse III to Nurse VII with their corresponding Salary Grade assignments;

WHEREAS, the said Circular covers all previous Nurse II to Nurse VII positions, which position attributes were modified pursuant to DBM BC No. 2020-4, whether regular, casual, or contractual in nature, full-time or part-time, now existing or hereafter created in the national government agencies (NGAs), including SUCs and GOCCs, and in LGUs covered by the Compensation and Position Classification System (CPCS) under RA No. 6758 or the "Compensation and Position Classification Act of 1989," as;

WHEREAS, in accordance with DBM Budget Circular No. 2021-2, Upgrading of the Former Nurse II/SG-15 position, to wit

Section 6.1 - The SG allocation of the former Nurse II, SG-15 positions is hereby upgraded by one (1) SG effective not earlier than June 1, 2021, as follows:




