WHEREAS, the law provides that any amendment to the Comprehensive Development Plan (CDP), Local Development Investment Program (LDIP) and Annual Investment Program (AIP), the Local Development Council shall approved thru Resolution any changes or updates to the aforementioned;

WHEREAS, Art. 182 (d) (iii) of the Implementing Rules and Regulations of RA 7160 mandates the Local Development Council (LDC) to formulate medium-term and annual public investment programs;

WHEREAS, the Local Finance Committee certifies the existence of savings and the availability of funds to realize the Programs, Projects and Activities (PPAs) as mentioned in CMDC Resolution No. 06-2021;

WHEREAS, pursuant to Section 17 of Republic Act No. 7160 (Local Government Code of 1991), the basic services to be provided by a Local Government unit includes the provision of services and facilities related to general hygiene and sanitation, beautification and solid waste collection;

WHEREAS, Section 17 (c) (3) of Republic Act No. 9003 provides that the Local Government Solid Waste Management Plan shall define and identify the specific strategies and activities to be undertaken by its component barangays, taking into account the hauling and transfer of solid waste from source or collection points to processing sites or final disposal sites, among others;

WHEREAS, Section 33 of Republic Act No. 9003 provides that Material Recovery facility shall be designed to received, sort, process and store compostable and recyclable material efficiently and in an environmentally sound manner. As such, the facility shall consider that the building and/or land layout and equipment must be designed to accommodate efficient and safe materials processing, movement and storage;

WHEREAS, COVID-19 hazard pay will be given to employees in the Local Government Unit (LGU) at their respective offices or work stations on the prescribed working hours by the head of agency or office amounting to Php500.00 per day during the period of Implementation of Enhance Community Quarantine and Modified Enhance Community Quarantine (MECQ) measures in the area of such office or work station, as provide by the President of the Philippines Administrative Order No. 43, to be funded through general fund proper;

WHEREAS, additional funds are needed for the following projects: Expenses for Hauling Services - Solid Waste to Sanitary Landfill, Markers for Historical Landmarks, Insurance Expenses;

WHEREAS, funds are needed for the following priority projects: Repair and Maintenance of Material Recovery Facility (MRCF), Improvement of Concierge, Construction of Storage Rooms, Renovation of Pharmacy Area, Establishment of Counselling Room, Improvement of Lamp Posts and Renovation of Fire Station and Sub-Station;

WHEREAS, the project 'Rehabilitation of the Wet Sector of the Public Market (Malolos City) needs to be included in the Local Development Investment Program (LDIP) 2020-2022 and endorsement from the Sangguniang Panlungsod as requirements for Local Government Support Fund - Financial Assistance to Local Government Unit (LGSF-FALGU);


