CITY RESOLUTION NO. 17-2020

A CITY RESOLUTION RESPECTFULLY REQUESTING THE BUREAU OF LOCAL GOVERNMENT FINANCE (BLGF) UNDER THE DEPARTMENT OF FINANCE (DOF) THROUGH HON. CARLOS DOMINGUEZ III TO ASSESS AND RECLASSIFY THE CITY OF MALOLOS OF ITS FINANCIAL CLASSIFICATION.

WHEREAS, at present, the City Government of Malolos is classified as 3rd Class City based on the 2008 assessment conducted by the Bureau of Local Government Finance (BLGF);

WHEREAS, the income of the City of Malolos in the year 2019 was Php1,130,021,961.79 and the projected income for 2020 is Php1,326,867,458.00 or an increase of at least Two Hundred Million Pesos;

WHEREAS, it is high time to re-assess or to conduct reclassification/evaluation as to the financial classification of the City of Malolos;

WHEREAS, based on Presidential Decree No. 465 of the Bureau of Local Government Finance (BLGF) was tasked to classify every Province, Municipality, or City as to their financial classification whether 1st, 2nd, 3rd, 4th, 5th or 6th;

WHEREAS, based on July 28, 2008 threshold, the City of Malolos is qualified to at least Second Class Classification (more than 320 but less than 400 Million);

WHEREAS, pursuant to Section 2 of Republic Act No. 4477, Provinces and Cities shall be classified by the Secretary of Finance every four Fiscal Years on the basis of the average annual income of the Local Units as certified by the the Chairman of the Commission on Audit (COA);

WHEREAS, the classification of Provinces, Cities and Municipalities serves, among other purposes, as basis for fixing the maximum tax ceilings imposable by the Local Governments under the Local Tax Code;

On motion of Hon. Nino Carlo C. Bautista, duly seconded by all Members present,

RESOLVED, as it is hereby resolved to formally request the reclassification of the City of Malolos based on its financial capacity to the Bureau of Local Government Finance (BLGF) under the Department of Finance (BLGF) through Hon. Carlos Dominguez III.
