CITY RESOLUTION NO. 18-2020

A CITY RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR, HON. GILBERT T. GATCHALIAN TO IMPLEMENT THE GRANT OF SALARY INCREASE TO QUALIFIED CITY EMPLOYEES BASED ON SALARY STANDARDIZATION LAW (TRANCHE V) UNDER REPUBLIC ACT NO. 11466 AND AS MANDATED UNDER LOCAL BUDGET CIRCULAR NO. 121.

WHEREAS, Section 10 of Republic Act No. 11466 also known as the Salary Standardization Law of 2019, grants the salary increase for Personnel of Local Government Units (LGUs) subject to compliance with Personnel Services (PS) limitation in the LGU Budget under Sections 325 and 331 of Republic Act No. 7160 also known as the Local Government Code of 1991;

WHEREAS, the said Salary increase needs the approval and authorization from the Sanggunian concerned as provided under Sections 447(a), 458 and 468(a) of Republic Act No. 7160;

WHEREAS, Section 10(a) of R.A. 11466 also mandates that the Salary Schedule for LGU Personnel shall not exceed 90% of the schedule under Sec. 7 of the above mentioned law and as mandated under Local Budget Circular No. 121;

WHEREAS, herein salary increase shall be implemented for not less than four (4) years, provided that the initial implementation shall not be earlier than January 01, 2020;

WHEREAS, the Sangguniang Panlungsod of the City Government of Malolos approved City Ordinance No. 02-2020 also known as the City Appropriation Ordinance for Fiscal Year 2020 which embody the necessary appropriation for the implementation of this salary increase in the amount of Php40,438,225.82 from the General Fund and Php2,094,610.76 from the Economic Enterprise;

WHEREAS, Section 16 of R.A. 7160 mandates the implementation of projects and programs by the Local Government Units (LGUs) that will redound to the general welfare of its constituents;

RESOLVED, as it is hereby resolved to authorize the implementation of Salary Standardization Law Tranche V for Fiscal Year 2020, effectively on January 1, 2020 and as mandated under Local Budget Circular No. 121.




