WHEREAS, the Department of Energy (DOE) spearheaded the e-trike modernization project to promote an eco-friendly and sustainable mode of public transportation;

WHEREAS, the objective of the project is to promote the modernization of the transport Sector and support the Tourism and business sector by providing as safe, efficient and environment friendly alternative mode of transport for Malolos constituents;

WHEREAS, the proposed E-Trike Deployment Project Plan of the City of Malolos is sufficiently and satisfactorily compliant to the requirements provided for by the Department of Energy (DOE);






