**A RESOLUTION RESPECTFULLY RECOMMENDING THE GRANTING OF APPROVAL OF THE MOTION TO RELEASE ON RECOGNIZANCE FILED BY ROME GRISSIN AVENDANO Y TORRES OF BARANGAY CAINGIN, THIS CITY BEFORE THE REGIONAL TRIAL COURT, THIRD JUDICIAL REGION, BRANCH 83 FOR VIOLATION OF SECTION 5 AND 11, ARTICLE II, R.A 9165, OTHERWISE KNOWN AS THE COMPREHENSIVE DANGEROUS DRUGS ACT OF 2002.**

**WHEREAS**, on December 3, 2021, this Office has received an Order/Notice on the application for recognizance filed by Rome Grissen Avendano Y Torres;  
 Copy of said Order is hereto attached and marked as Annex "A".

**WHEREAS**, Section 13, Article III of the 1987 Constitution provides that all persons, except those charged with offenses punishable by reclusion perpetua when evidence of guilt is strong, shall before conviction, be bailable by sufficient sureties, or be released on recognizance as may be provided by law';

**WHEREAS**, Republic Act No. 10389, otherwise known as the "Recognizance Act of 2012" was enacted to uphold the mandate of the Constitution by institutionalizing recognizance as a mode of granting the release of an indigent accused in a criminal case in custody of the law;

**WHEREAS**, the Sangunian upon receipt of the said order has acted upon the order of the Court and immediately required the representative of the accused to submit before the Sangunian all the documents needed for the consideration of the Council and for its legislative action pursuant to Section 6, (d) of said RA No. 10389;

**WHEREAS**, after thorough evaluation of the records submitted and upon coordination with NGO Presidents, the Council believes that the peace of the community will not be disturbed upon the temporary release of the accused, hence, **ENDORSES THE APPROVAL OF THE APPLICANT FOR RECOGNIZANCE:**
