**A CITY RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR - ENGR. GILBERT T. GATCHALIAN TO ENTER AND SIGN IN BEHALF OF THE CITY GOVERNMENT OF MALOLOS INTO A MANAGEMENT AGREEMENT WITH THE ASSOCIATION OF BARANGAY CAPTAINS (ABC) OF THIS CITY AND WITH LGU - PAOMBONG FOR THE USE AND DISTRIBUTION OF THE 100 E-TRIKES.**

**WHEREAS**, Section 16 of Republic Act No. 7160 also known as the Local Government Code of 1991 mandates that every Local Government Units (LGU's) shall formulate programs and projects that will promote the general welfare of their constituents;

**WHEREAS**, Section 9 of the 1987 Philippine Constitution provides that the state shall promote a just and dynamic social order that will ensure the prosperity and independence of the nation and free the people from poverty through policies that provide adequate social services, promote full employment, a rising standard of living, and an improved quality of life for all;

**WHEREAS**, the Department of Energy (DOE) spearheaded the e-trike modernization project to promote an eco-friendly and sustainable mode of public transportation;

**WHEREAS**, the City Government of Malolos is a recipient of the project and acquired 100-E-trike units by way of a Deed of Donation entered into by the parties on May 27, 2019;

**WHEREAS**, each 51 barangays of the City of Malolos will receive (1) unit of E-Trike to serve as their service vehicle during official trips;

**WHEREAS**, LGU - Paombong will receive (30) units of the E-Trike as part of the sisterhood agreement between the City and the said Municipality;

**NOW THEREFORE**, on motion of **Hon. Nino Carlo C. Bautista** duly seconded by all Members present, that:

**RESOLVED**, as hereby resolved, to authorized City Mayor - Engr. Gilbert T. Gatchalian, to enter and sign in in behalf of the City Government of Malolos, a Management Agreement with the Association of Barangay Captains (ABC) of this City and with LGU - Paombong for the use and distribution of the 100 E-Trikes.
