CITY RESOLUTION NO. 22-2021

A CITY RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ENGR. GILBERT T. GATCHALIAN TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY GOVERNMENT OF MALOLOS WITH THE DEPARTMENT OF EDUCATION (DepEd) FOR THE USE OF SCHOOLS AS EVACUATION CENTERS AND VACCINATION SITE.

WHEREAS, disaster as defined in Republic Act No. 10121 (also known as the Philippine Disaster Risk Reduction and Management Act of 2012), refer to a serious disruption of the functioning of a community or a society involving widespread human, material, economic, or environmental losses and impacts, which exceeds the ability of the affected community or society to cope using its own resources. Disasters are often described as a result of the combination of: the exposure to a hazard; the conditions of vulnerability that are present; and insufficient capacity or measures to reduce or cope with the potential negative consequences. Disaster impacts may include loss of life, injury, disease and other negative effects on human, physical, mental and social well-being, together with damage to property, destruction of assets, loss of services, social and economic disruption and environmental degradation;

WHEREAS, it is the policy of the State, as embraced in the Implementing Rules and Regulations of Republic Act No. 10121, to institutionalize the polices, structures, coordination mechanisms and programs with the continuing budget appropriation on disaster risk reduction from national down to local level towards building a disaster-resilient nation and communities;

WHEREAS, for efficient, effective and economical governance the purpose of which is general welfare of the city and its inhabitants, the City Government of Malolos shall carry out such emergency measures as may be necessary during and in the aftermath of man-made and natural disasters and calamities, pursuant to Chapter III, Article I, Section 455 (vii) of RA No. 7160 also known as the Local Government Code of 1991;

WHEREAS, educational facilities in the schools under the jurisdiction of the City Schools Division of Malolos shall be utilized properly. The use of the ground and facilities of the school other than for the school activities must be subject to the approval of the Schools Division/City Schools Superintendent. Among other public activities and utilization of the school grounds and facilities which may be permitted by the Schools Division Superintendent thru the principal/head teacher is the use of school buildings/ classrooms as evacuation centers in case of natural calamities, pursuant to Chapter 5 (c) of the 2010 Educational Facilities Manual;

WHEREAS, Pursuant to Section 5 of Republic Act also known as the "Children's Emergency Relief and Protection Act", only in cases where there is no other available place or structure which can be used as a general evacuation center may a school or child development center be used as an evacuation center;

WHEREAS, Pursuant to Section 5, Rule 6 of the IRR of R.A. 10821, Schools and child development centers shall not be used as transitional shelters due to the negative effects that such use may cause to the educational of children living inside and outside transitional shelters;

WHEREAS, part of the City Government's Vaccination Plan is the establishment of vaccination site to the strategically identified for easy access and for the efficient implementation of the vaccination program against COVID-19;

WHEREAS, the City aimed to cover at least 60-70% of its population to reach herd immunity from COVID-19 to combat the spread of the virus;

WHEREAS, Section 22 (c) of R.A. 7160 also known as the Local Government Code of the Philippines provides that the local chief executive may represent the LGU into a contract provided that the sanggunian, unless otherwise provided in the Code, no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned;

NOW THEREFORE, on motion of **Hon. Nino Carlo C. Bautista** duly seconded by all Members present,

RESOLVED, as hereby resolved, to authorized City Mayor, Hon. Engr. Gilbert T. Gatchalian, to enter and sign into a Memorandum of Agreement (MOA) in behalf of the City Government of Malolos with the Department of Education (DepEd) for the use of schools as evacuation centers and vaccination site.


