GATCHALIAN, TO REPRESENT THE CITY GOVERNMENT OF MALOLOS AND TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE MUNICIPAL GOVERNMENT OF PAOMBONG THROUGH HON. MARYANNE P. MARCOS, MUNICIPAL MAYOR ON THE IMPLEMENTATION OF SISTERHOOD OR TWINNING AGREEMENT BETWEEN LOCAL GOVERNMENT UNITS FOR CULTURAL, TOURISM, ECONOMIC DEVELOPMENT AND PROJECT COOPERATION AND PARTNERSHIP.



NOW THEREFORE, on motion of Hon. Nino Carlo C. Bautista duly seconded by all Members present,


