A RESOLUTION ACKNOWLEDGING/DESIGNATING HON. ENRICO C. CAPULE, CHAIRMAN - COMMITTEE ON RULES, HON. NINO CARLO C. BAUTISTA, CHAIRMAN - COMMITTEE ON REVIEW AND HON. KIRK LOUIS NICOLAS, CHAIRMAN - COMMITTEE ON ENVIRONMENT AND NATURAL RESOURCES, AS THE DULY REPRESENTATIVES OF THE SANGGUNIANG PANLUNGSOD TO THE REGULATORY REFORM TEAM (RRT) AND TO SERVE AS SUCH UNTIL THE END OF HIS TERM AS ELECTED COUNCILOR OF THE CITY OF MALOLOS.

WHEREAS, Republic Act No. 11032 also known as the Ease of Doing Business and Efficient Government Service Delivery Act of 2018 mandates the curtailment of prohibited red tapes in the public service and bureaucracy;

WHEREAS, Republic Act No. 9485 also known as the Anti-Red Tape Act of 2007 states the policy of the state to promote integrity, accountability, proper management of public affairs and public property as well as to establish effective practices aimed at the prevention of graft and corruption in government;

WHEREAS, JOINT MEMORANDUM CIRCULAR NO. 2019-01 dated December 10, 2019, which was issued by the Department of the Interior and Local Government (DILG) and the Anti-Red Tape Authority (ARTA) aims to ensure good regulatory practices in the policy making process of Local Government Units;

WHEREAS, item 6.1.2.1 of the above mentioned Joint Memorandum Circular mandates the creation of the Regulatory Reform Team (RRT) in order to facilitate the activities of the Regulatory Reforms;

WHEREAS, the composition of the said RRT requires at least three (3) members of the Sangguniang Panlungsod concerned;

WHEREAS, it is mandatory to this august body to elect among its members a representative of the aforementioned entity;

WHEREAS, it is more fitting that the said representative should come from the members preferably the chairman of the Committee on Rules, Review and Environment and Natural Resources because the said committee is specifically tasked and has jurisdictions to matters in relation to legislative undertakings of this Honorable Body;

WHEREAS, the Chairman of the said committee is Hon. Enrico C. Capule, Hon. Nino Carlo C. Bautista and Hon. Kirk Louis Nicolas, seasoned public servants, whose experiences, undoubtedly, is of great service to this locality and its constituents;
