A CITY RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ENGR. GILBERT T. GATCHALIAN TO ENTER AND SIGN IN BEHALF OF THE CITY GOVERNMENT OF MALOLOS INTO A TEMPORARY SUPPLY AGREEMENT WITH SMART COMMUNICATIONS, INC. GSM FACILITY.

**WHEREAS**, Section 16 of Republic Act No. 7160 also known as the Local Government Code of 1991 mandates that every Local Government Units (LGU's) shall formulate programs and projects that will promote the general welfare of its constituents;

**WHEREAS**, it is the primary objective of the City Government of Malolos to give effective and efficient delivery of services to its constituents with the use of technological advancement in its transactions;

**WHEREAS**, Smart desires to provide optimum coverage for the employees and patrons of City Government through the installation of Smart telecommunication facilities with an indoor Distributed Antenna System (DAS);

**WHEREAS**, the City Government shall allow Smart to use the assigned areas for suitable telecommunications site and all expenses connection with the installation and maintenance shall be for the Smart's exclusive account;

**WHEREAS**, only allow authorized employees/agents of Smart access to and from the assigned areas on office hours operation or on special hours authorized by the City Government of Malolos;

**WHEREAS**, the City Council adopted and passed City Resolution No. 151-2020 which authorized the City Mayor to enter into a Memorandum of Agreement with Smart Communications, Inc. for its signal booster to the New Malolos City Hall;

**WHEREAS**, Section 22 (c) of Republic Act No. 7160 also known as the Local Government Code of 1991 provides that before a Chief Executive may enter and sign into any contract in behalf of the Local Government Unit concerned, there is a need for a prior authorization from the Sangguniang Panlungsod;

**NOW THEREFORE**, on motion of Hon. Nino Carlo C. Bautista duly seconded by all Members present,

**RESOLVED**, as hereby resolved, to grant authorization to the Honorable City Mayor Engr. Gilbert T. Gatchalian to enter and sign on behalf of the City Government of Malolos into a Temporary Supply Agreement with Smart Communications, Inc. GSM facility.




