CITY RESOLUTION NO. 264-2020

A CITY RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ENGR. GILBERT T. GATCHALIAN TO ENTER AND SIGN IN BEHALF OF THE CITY GOVERNMENT OF MALOLOS INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL OFFICE III REPRESENTED BY ITS REGIONAL DIRECTOR, DIR. MARITES M. MARISTELA FOR THE IMPLEMENTATION OF EMERGENCY SUBSIDY PROGRAM-SOCIAL AMELIORATION PROGRAM (ESP-SAP).

WHEREAS, Under Section 4(f) (1) and (f) (3) of Republic Act (RA) No. 11494 or the "Bayanihan to Recover as One Act", the DSWD is mandated to provide emergency subsidy of Five Thousand (Php 5,000.00) to Eight Thousand Pesos (Php 8,000.00) and likewise implement other Social Protection Program, [i] to low income households in areas placed under granular lockdown, [ii] to households with recently returned and undocumented Overseas Filipino Workers (OFWs) and [iii] to low-income households which are qualified to receive, under Section 4(c) of RA No. 11469, but were not granted the same;






WHEREAS, To fast-track the distribution of the emergency subsidy to these targets and likewise the implementation of key social protection programs, the DSWD has been given authority under Section 4 (pp)(10) of said law to transfer funds to Local Government Units (LGUs) for purposes of facilitating the distribution of assistance to qualified beneficiaries;

WHEREAS, To operationalize these mandates under RA No. 11494 which effectivity date is September 14, 2020 to December 19, 2020, the DSWD has issued Memorandum Circular (MC) No. 30 or the "Special Guidelines on the Implementation of the Provisions of Republic Act No. 11494 or the 'Bayanihan to Recover as One Act' Concerning DSWD";

WHEREAS, In light of the continuing local transmission of Coronavirus Disease (COVID) 2019 as well as the extension of the State of Calamity until September 12, 2021, under Proclamation No. 1021, Series of 2020, the DSWD and the LGU's shall extensively collaborate to undertake the efficient, safe and proper delivery of the emergency subsidy and the social services identified in RA No. 11494 i.e. Assistance to Individuals in Crisis Situation (AICS) and to those in need at the community level and Social Pension for Indigent Senior Citizens, as mandated by RA No. 11494, to be implemented during its effectivity and as part of the recovery stage of DSWD social amelioration program.

WHEREAS, section 16 of Republic Act No. 7160 also known as the Local Government Code of 1991, mandates the promotion of the general welfare of its constituents through programs and projects by the Local Government Unit concerned;
