CITY RESOLUTION NO. 280-2020

A CITY RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ENGR. GILBERT T. GATCHALIAN TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) ON BEHALF OF THE CITY GOVERNMENT OF MALOLOS WITH THE CENTRAL LUZON CENTER FOR HEALTH DEVELOPMENT - DEPARTMENT OF HEALTH FOR THE FUND TRANSFER TO THE CITY OF COVID-19 BENEFITS INCLUDING ACTIVE HAZARD DUTY PAY (ADHP) AND SPECIAL RISK ALLOWANCE (SRA) FOR ELIGIBLE HEALTH WORKERS PURSUANT TO BAYANIHAN TO RECOVER AS ONE ACT OR RA 11494.

WHEREAS, thru the proclamation of His Excellency Rodrigo Roa-Duterte, President of the Republic of the Philippines, the entire country was placed under the State of Calamity and State of Public Health Emergency brought about by the spread of COVID-19;

WHEREAS, following the said proclamation was the order placing the Province of Bulacan to General Community Quarantine (GCQ) to suppress the spread of COVID-19 and contain the said virus;

WHEREAS, the Department of Health (DOH) Central Luzon Center for Health Development, as the implementing arm of the Department of Health within Central Luzon, recognizes the invaluable contribution of all Public and Private Health Workers at this time of national health emergency, and has for this purpose, implements the mandate under Section 4 (h) of Republic Act No. 11494, otherwise known as the "Bayanihan to Recover as One Act";

WHEREAS, Administrative Order Nos. 35 and 36 both dated November 16, 2020 and signed by President Rodrigo Roa-Duterte, on the grant of Active Hazard Duty Pay (AHDP) and Special Risk Allowance (SRA) to all qualified frontliners directly catering to COVID-19 patients for every month of service rendered;

WHEREAS, it is the primary objective of the City Government of Malolos to promote Public Health and Safety among its constituents;

WHEREAS, the Memorandum of Agreement (MOA) between the parties aims to execute and implement the mandate under Section 4 (h) of Republic Act No. 11494, Administrative Order Nos. 35 and 36 series of 2020;

WHEREAS, the City Government of Malolos expresses its salute and deepest gratitude to all of its frontliners and employees directly contributing to its campaign against COVID-19;



Gatchalian to enter and sign into a Memorandum of Agreement (MOA) on behalf of the City Government of Malolos with the Central Luzon Center for Health Development - Department of Health for the fund transfer to the City of COVID-19 benefits including Active Hazard Duty Pay (ADHP) and Special Risk Allowance (SRA) for eligible health workers pursuant to Bayanihan to Recover as One Act or RA 11494.

RESOLVED FURTHER, to include all Public Health Workers and barangay Health workers in the City Government of Malolos to the official list that will be submitted to the Central Luzon Center for Health Development - Department of Health.






