WHEREAS, On December 18, 2020, His Excellency President Rodrigo-Roa Duterte signed and issued Administrative Order No. 37 series of 2020 entitled - Authorizing the Grant of Service Recognition Incentive (SRI) to Government Employees for Fiscal Year (FY) 2020;

WHEREAS, the said Administrative Order authorizes the grant of a one-time Service Recognition Incentive (SRI) at a uniform amount not exceeding Ten Thousand Pesos (Php10,000.00) for each qualified government employees;

WHEREAS, Section 6 of Administrative Order No. 37 series of 2020 explicitly provides the grant of the said incentive to the employees of the Local Government Units (LGU's) including those in the barangays to be determined by their respective Sanggunian and shall be charged against their respective 2020 Local Government Funds;

WHEREAS, On December 22, 2020, the Department of Budget and Management issued Budget Circular No. 2020-6 "Guidelines on the Grant of the One-Time Service Recognition Incentive to Government Employees for FY 2020;

WHEREAS, the City Local Finance Committee certifies the availability of funds and cash availability for this purpose;

WHEREAS, government employees deserve to be rewarded to recognize their collective and unceasing participation in and invaluable contribution to the Administration's continuing efforts toward the establishment of streamlined government processes and more responsive delivery of public service;






