CITY RESOLUTION NO. 57-2020

A RESOLUTION ENJOINING ALL GOVERNMENT AND PRIVATE ESTABLISHMENT IN CITY OF MALOLOS TO ADOPT A STRINGENT MEASURES TO FIGHT THE SPREAD OF CORONAVIRUS DISEASE 2019 (COVID 19).

WHEREAS, the NCOV/COVID-19 Task Force has resolved to adopt the necessary measures to fight the spread of coronavirus diseases 2019 (Covid 19);

WHEREAS, in the resolution, employers in the private sector and the government are encouraged to implement measures to help curtail the spread of the virus;

WHEREAS, there are some business establishments in the city wherein their employees were not provided with proper protective gears, such as face mask and other gadgets for their protection when dealing with their customer;

WHEREAS, food establishment must provide their food handlers and servers with the necessary protective measures to avoid virus transmission;

WHEREAS, for the government sector, the resolution mandates that health workers, first responders will be provided with protective gears, health interventions, stress debriefing and appropriate technology to minimize face to face contact;

WHEREAS, the City government must consider all critical factors with the aim of safeguarding the health of its residents;

NOW THEREFORE, on motion of Hon. Emmanuel R. Sacay, duly seconded by all Members present,

RESOLVE, as it is hereby resolved to enjoin all government and private establishments in City of Malolos to adopt the necessary precautionary measures to fight the spread of Coronavirus Disease 2019 (COVID 19).
