CITY RESOLUTION NO. 58-2020

A RESOLUTION URGING SHOPPING MALLS OWNERS AND OPERATORS TO SUSPEND ALL FORMS OF SPECIAL DISCOUNTS SALES AND CONCERTS IN THEIR RESPECTIVE MALLS IN OBEYANCE WITH THE PRESIDENT DUTERTE'S PRECAUTIONARY MEASURE OF AVOIDING CLOSE ENCOUNTER WITH THE COVID 19 POSSIBLE CARRIES,

WHEREAS, as a responsible and a proactive business owner, they need to work closely with the national and local government units to support their efforts of containing the spread of COVID 19 and ensure the well being of their tenants, shoppers and employees;

WHEREAS, it is commendable that some supermalls issued a "Public Service Advisory" that the utmost safety of their tenants, customers and employees are their priorities and strict measures are in place in their malls to protect the public from the COVID 19 virus;

WHEREAS, there are also some malls that despite of the stern warning by no less than the President, there are trying to entice shoppers by declaring super discount sale of all sort of sale's gimmicks which is contrary to the efforts being done by the national and local government units;

WHEREAS, it is understandable that malls sales are greatly affected by the COVID 19 virus and they are trying to recover their loss by declaring "SALE OF ALL SALES", "MEGA SALES", "SUPER SALES", "CONCERTS" and other related events to attract and gathered big crowds'

WHEREAS, in situation like this, the general welfare of the public is the utmost concern of the city as embodied in our Philippine Constitution over the financial gain of shopping malls owners and operators.

NOW, THEREFORE, on motion of Hon. Emmanuel R. Sacay, duly seconded by all Members present,

RESOLVE, as it is hereby resolved to urge shopping malls owners and operators to suspend all forms of special discounts sales and concerts in their respective malls in obeyance with the president duterte's precautionary measure of avoiding close encounter with the ncov possible carriers.

Resolved further, that all shopping malls in the territorial jurisdiction of the City shall be furnished a copy of this resolution either by registered mail or email for their information and ready reference.
