**Now therefore**, on motion of Hon. Nino Carlo C. Bautista, duly seconded by all Members present,


**RESOLVED**, as it is hereby resolved to amend Rule VII Section 14 'The Session' of City Resolution No. 71-2019 and shall be read as follows:
