GATCHALIAN TO ENTER AND SIGN INTO A DEED OF DONATION WITH THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES (DENR) THROUGH THE ENVIRONMENTAL MANAGEMENT BUREAU (EMB) FOR THE DONATION OF ONE (1) UNIT OF BIODEGRADABLE WASTE SHREDDER (12HP DIESEL ENGINE) AND ONE (1) UNIT OF COMPOSTER FIVE (5) HP.

WHEREAS, it is the primary objective of the City Government of Malolos to protect the environment through the implementation of national Laws such as Republic Act No. 9003 also known as the Ecological Solid Waste Management Act of 2000, City Ordinances such as the Sagip Ilog Ordinance, City Harbor Day and the decisions of the Honorable Supreme Court in the matter of the issuance of the Continuing Mandamus ordering Provinces and Cities to clean Manila Bay;

WHEREAS, the EMB is the lead agency in the implementation of Solid Waste management (SWM) in the country in coordination with other partners and stakeholders to provide guidance and technical assistance on concerns on waste management strategies and options to LGUs;

WHEREAS, Solid Waste Management is a pervasive problem and a looming crisis in many areas in the Philippines, focusing for decades on collection and hauling and not on waste treatment and disposal, thus it has become very expensive;

WHEREAS, many well-meaning projects, laws, rules and regulations have achieved little so far with Local Government Units (LGUs) facing a massive challenge in managing rapid and largely unplanned urban growth;

WHEREAS, Section 8 of RA 9003 states that the Department shall provide technical and other capability building assistance and support to the LGUs in the development and implementation of local solid waste management plans and programs;

WHEREAS, after 19 years of implementation of RA 9003 or the Ecological Solid Waste Management Act of 2000, continuing challenges exist in solid waste collection, establishment of Material Recovery Facilities (MRF), the lack of enforcement of the basic requirements of RA 9003 and poor solid waste diversion;

WHEREAS, the City of Malolos, Bulacan has shown interest to participate in the project and has agreed to fulfill, its requirements under the terms and Conditions hereunder stipulated;

WHEREAS, DENR-EMB freely and voluntarily gives, conveys and transfers by way of donation with the City Government of Malolos the following:

1. One (1) unit of biodegradable waste shredder with a minimum capacity of 250 kilograms, powered by 12 HP diesel engine with electric and manual start, composed of shredding chamber, shredder blades; and
2. One (1) unit of composter with a capacity of 1,000 kilograms per batch for every 24 hours' operation powered by five (5) HP by Electric Motor, 220v, 60hz, single phase with speed reducer 1:10 type 120.

WHEREAS, the City Government of Malolos is willing to accept the said donation.

On motion of **Hon. Nino Carlo C. Bautista** duly seconded by all Members present,

RESOLVED, as it is hereby resolve, to authorize the Honorable City Mayor - Engr. Gilbert T. Gatchalian, to enter and sign into a Deed of Donation with the Department of Environment and Natural Resources (DENR) through the Environmental Management Bureau (EMB) for the donation of one (1) unit of Biodegradable Waste Shredder (12 HP Diesel Engine) and one (1) unit of Composter five (5) HP.
