WHEREAS, Art. 182 (d) (iii) of the Implementing Rules and Regulations of RA 7160 mandates the Local Development Council (LDC) to formulate medium-term and annual public investment programs;

WHEREAS, Department of Interior and Local Government (DILG)-Department of Budget and Management (DBM) Joint Memorandum Circular No. 01 dated 27 March, 2020 provides additional guidelines on the utilization of the twenty percent (20%) of the annual internal revenue allotment for development projects in view of the Corona Virus Disease 2019 (COVID-19) situation;
