GATCHALIAN TO ENTER AND SIGN INTO A MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY GOVERNMENT OF MALOLOS WITH THE DEPARTMENT OF INFORMATION AND COMMUNICATIONS TECHNOLOGY (DICT) FOR THE USE OF THE ELECTRONIC BUSINESS PERMITS AND LICENSING SYSTEM (E-BPLS) SOFTWARE IN THE COMPUTERIZATION OF BUSINESS PERMITS AND LICENSING SYSTEM.

WHEREAS, Section 16 of Republic Act No. 7160 also known as the Local Government Code of 1991 mandates the implementation of projects and programs by the Local Government Units (LGUs) that will redound to the general welfare of its constituents;

WHEREAS, one fo the priorities of the City Government of Malolos is to modernize the transactions, applicationS and services of the City especially the issuance of Business Permits and License;

WHEREAS, the DICT is a government agency mandated by the law to be the primary policy, planning, coordinating, implementing, entity of the government that will plan, develop, and promote the national ICT development plan;

WHEREAS, as per the Department of the Interior and Local Government, Department of Trade and Industry, and DICT Joint Memorandum Circular (JMC) No. 01 on the Revised Standards in Processing Business Permits and Licenses in All Cities and Municipalities signed on 30 August 2016, Section 6.9.4.4, the DICT has been mandated to make available to qualified local government units (LGUs) a software that can be used in the computerization of their business permits and licensing system;

WHEREAS, under Section 11 (c.) of R.A. 11032 of otherwise known as "Ease of Doing Business and Efficient Government Service Delivery Act of 2018", which provides that: Cities/Municipalities are mandated to automate their business permitting and licensing system or set up an electronic BOOS within a period of three (3) years upon effectivity of this Act for a more efficient business registration processes. Cities/Municipalities with electronic BOSS shall develop electronic versions licenses, clearances, permits, certifications or authorizations with the same level of authority, which may be printer by business in the convenience of their offices. The DICT shall make available to LGUs the software for the computerization of the business permit and licensing system. The DICT, DTI, and DILG, shall provide technical assistance in the planning implementation of a computerization or software-enabled business permitting licensing system;

WHEREAS, the DICT has developed a cloud-based Electronic Business Permits and Licensing System (eBPLS) Software and is the exclusive owner of the eBPLS Software;

WHEREAS, the City of Malolos is interested in the implementation of business permits software which shall computerize the processing of their business permit applications and has decide to avail the software developed by the DICT;

WHEREAS, the DICT has offered to grant the City of Malolos the access/use of the eBPLS Software as well as to provide the necessary service for its configuration, setup and testing, and the latter accept the said offer;

WHEREAS, this MOA is governed by RA No. 10173, "An Act Protecting Individual Personal Information in Information and Communications Systems in the Government and the Private Sector, creating for this purpose a National Privacy Commission (NPC), and other purposes" otherwise known as "Data Privacy Act (DPA) of 2012" as well as the Implementing Rules and Regulations (IRR) and its issuance by the NPC;

WHEREAS, the City of Malolos shall ensure the confidentially and integrity of the data gathered from the public;

WHEREAS, R.A. 8792, otherwise known as "Electronic Commerce Act of 2000" was enacted to facilitate domestic and international dealings, transactions,, arrangement, agreements, contracts and exchanges and storage of information through the utilization of electronic, optical and similar medium, mode, instrumentality and technology to recognized the authenticity and reliability of electronic documents related to such activities and to promote the universal use of electronic transaction in the government and general public;

On motion of Hon. Nino Carlo C. Bautista, duly seconded by Members present,

RESOLVED, as it is hereby resolved, to authorize the Honorable City Mayor, Engr. Gilbert T. Gatchalian, to sign and enter in behalf of the City Government of Malolos into an Agreement with the Department of Information and Communications Technology (DICT) for the use of the Electronic Business Permits and Licensing System (e-BPLS) software in the computerization of Business Permits and Licensing System.
