GATCHALIAN, TO ENTER AND SIGN ON BEHALF OF THE CITY GOVERNMENT OF MALOLOS INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE BUSINESS FOR SOCIAL PROGRES, INC. (PBSP) FOR THE IMPLEMENTATION OF THE ADVANCING CLIENT-CENTERED CARE AND EXPANDING SUSTAINABLE SERVICES FOR TUBERCULOSIS (ACCESS TB) PROJECT.

WHEREAS, Section 16 of Republic Act No. 7160 also known as the "Local Government Code of 1991" provides that every Local Government Units (LGU's) shall formulate programs and projects that will promote general welfare of its constituents;

WHEREAS, one of the priorities of the City Government of Malolos is to eliminate and combat the spread of Tuberculosis;

WHEREAS, PBSP, is the principal recipient of the Grant provided by The Global Fund to Fight AIDS, Tuberculosis and Malaria by virtue of the *Grant Confirmation*, to benefit the Program entitled "*Advancing Client-centered Care and Expanding Sustainable Services for TB*". In fulfillment of its obligations under the Grant Confirmation, PBSP is implementing the ACCESS TB Project (Advancing Client-centered Care and Expanding Sustainable Services for TB Project) in the Philippines, the goal of which is to further reduce the prevalence, incidence and morality of Tuberculosis in the Philippines;

WHEREAS, one of the key service delivery areas of the GF Project is to support the Philippine Department of Health (DOH) in the scale-up of the Programmatic Management of Drug-Resistant Tuberculosis (PMDT) across the country;

WHEREAS, the DOH works through Local Government Units, private and public health facilities, hospitals and institutions to effectively and efficient deliver quality clinical and laboratory services, and TB care and treatment among TB patients covered by the GF Project;
