CITY RESOLUTION NO. 80-2020

A RESOLUTION REQUESTING THE CITY MAYOR AND ALL BARANGAY CAPTAINS TO PROPOSE AND PRE-POSITION QUARANTINE FACILITY SITES WHICH WILL SERVE AS ISOLATION AREAS FOR THE USE OF THE PERSONS UNDER MONITORING (PUMs) AND PERSONS UNDER INVESTIGATION (PUIs) FOR COVID-19 IN THE CITY OF MALOLOS.

WHEREAS, by virtue of the Memorandum from the Executive Secretary dated 16 March 2020, and pursuant to Proclamation Nos. 929 and 922 (s. 2020) and Republic Act 11332, the entire of Luzon was placed under Enhanced Community Quarantine following the sharp increase in the number of confirmed COVID-19 cases throughout the country;

WHEREAS, on 07 April, 2020 the President of the Republic of the Philippines officially approved the extension of the Enhanced Community Quarantine over Luzon until 30 April, 2020;

WHEREAS, with the current trend of the number of cases of Covid-19 patients, having identified seven (7) confirmed positive cases, twenty-six (26) PUIs and eight hundred sixty-six (866) PUMs in the City of Malolos as of 06 April 2020, and the way it is being transmitted from one person to another, it is highly recommended to further contain the spread of coronavirus;

WHEREAS, under Section 4 (b) of Article IV of the City Ordinance 10-2020, An Ordinance Providing For The City Of Malolos Comprehensive Covid-19 Prevention, Control, And Management Program, the Office of the Mayor is directed to establish additional quarantine sites to assist those living in confined spaces (i.e., apartments, dormitories, etc.) where other unexposed individuals or asymptomatic individuals will be at increased risk of exposure, to undergo self-quarantine in a designated quarantine site of the City;

On motion of Hon. Dennis D. San Diego, duly seconded by all Members present,

RESOLVED, AS IT IS HEREBY RESOLVED, to request to the City Mayor and all Barangay Captains to propose and pre-position quarantine facility sites which will serve as isolation areas for the use of the Persons Under Monitoring (PUMs) and Persons Under Investigation (PUIs) for COVID-19 in the City of Malolos.
